Why do we care about youth substance use?

We value every youth and want them to be healthy & happy adults

We know now that the brain is still developing until age 25+

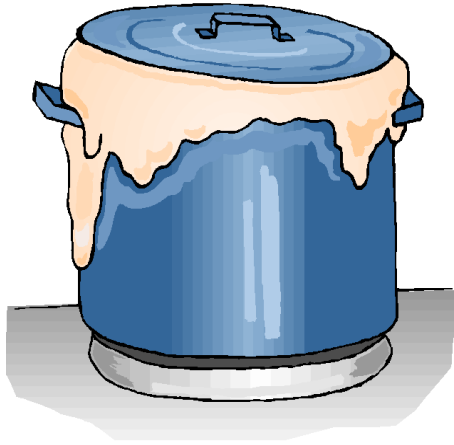
There can be worrisome consequences from substance use — lower GPA's, and higher rates of delinquency, dropout, early pregnancy.

Youth who use alcohol before age 13 are *five times more likely* to become dependent than youth who delay until age 21 or older

Marijuana can be addictive; it is the #1 reason youth seek substance use disorder treatment in Massachusetts

Opioid drug misuse in young adults may have its roots in earlier teenage substance use

Preventing & Reducing Teen Substance Use



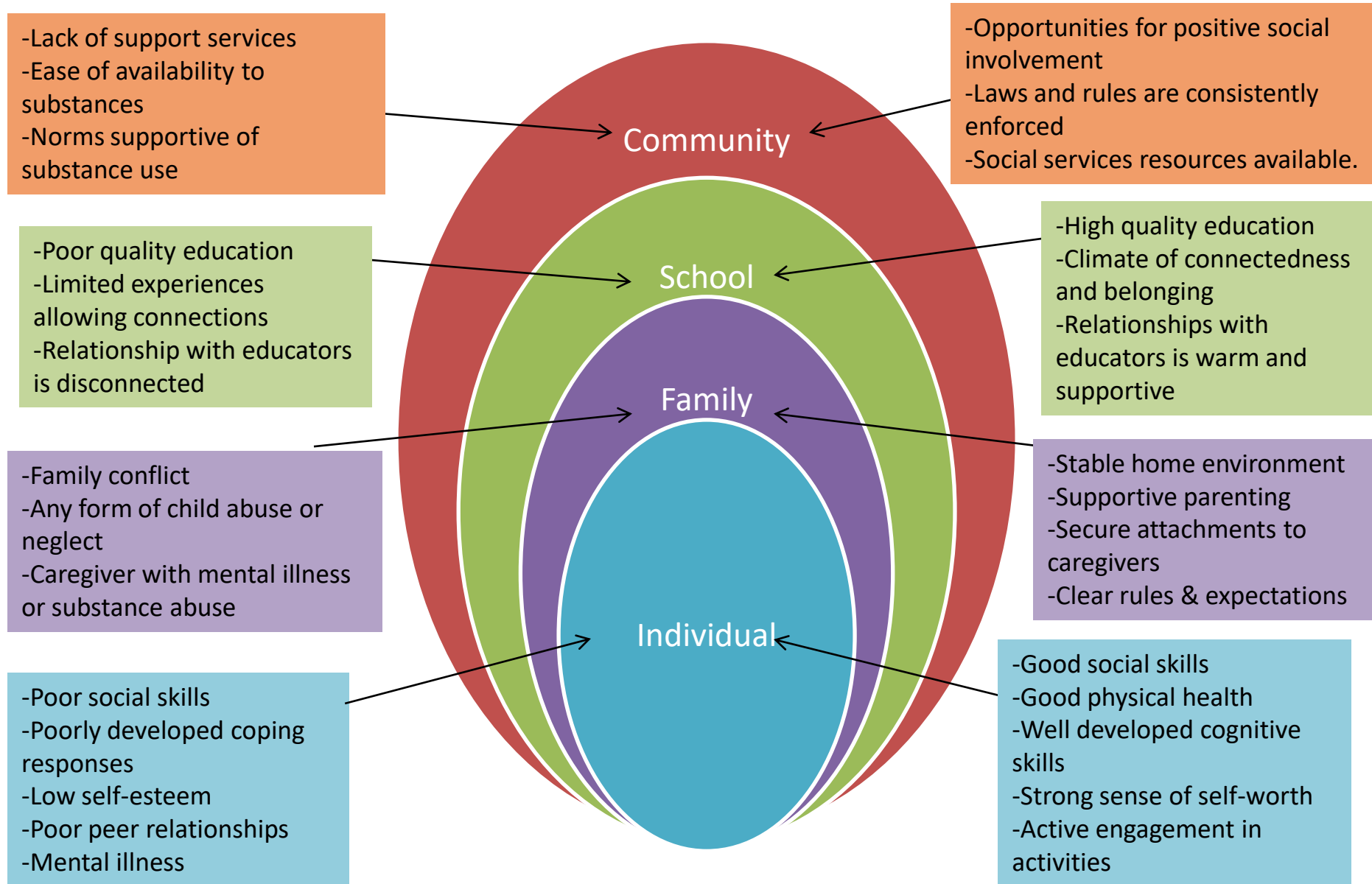
There is a lot 'cooking' in the adolescent brain.

Harmful substances like tobacco, nicotine, alcohol, marijuana and other drugs turn up the heat.

By creating environments that "turn down the temperature" for youth, we can prevent problems from boiling over or even starting to simmer.

Just like we turn down the heat on a stove, communities can keep youth from harm by making sensible changes.

Risk & Protective Factors at Multiple Levels



Substance Use Disorder

There are three factors that greatly increase the risks for someone to develop a Substance Use Disorder

Age of First Use

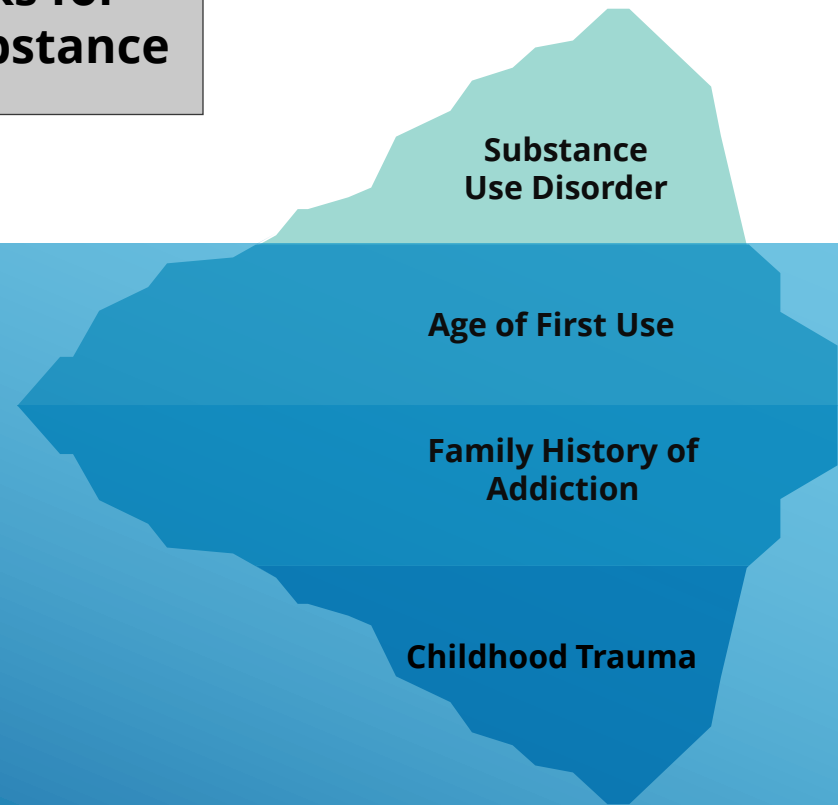
The earlier a individual initiates use, the greater the likelihood of creating dependency upon substance. 90% of addiction begin in the teenage years.

Family History of Addiction

Individuals with a genetic link to family members with substance use disorder are more likely to develop an addiction. 1 in 2 youth with a family history who begin use in their teenage years are likely to develop an addiction.

Childhood Trauma

Individuals with higher frequency or severity of adverse childhood experiences (ACEs) has a greater likelihood of developing a substance use disorder, as well as many other mental and physical health impacts.

Survey Validation

Six strategies were used to assess the validity students' survey responses.

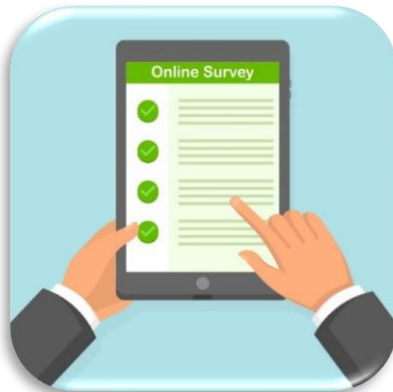
Impossibly high reports of substance use	Exaggerated frequency of antisocial behaviors	Use of a fictitious drug	Inconsistency between lifetime and 30day use	Failure to complete 25% or more of the survey	Self described as “not honest”
Students who reported an average of four or more daily uses of the following drugs—cocaine, LSD/Psychedelics, Ecstasy, methamphetamine and heroin—were eliminated from the survey data set.	Students who reported an unrealistically high frequency of 5 antisocial behaviors, such as “attacking someone with intent to harm” and “getting suspended”—more than 120 instances within the past year—were removed from the analysis.	Students reported any use of the fictitious drug, surveys were not included in the analysis of the findings.	Such as reporting use of a drug within the past 30 days but not reporting it for lifetime use. Records with two or more such inconsistencies were removed.		Students who responded to a final survey questions about honesty by saying that "they were not honest at all" were removed from the analysis.

Drug Free Communities “Core Measures”

Required to provide data every two years on the following core measures for alcohol, tobacco, marijuana, and prescription drugs for three grades. Quaboag Hills surveys students in the 8th, 10th and 12th grades.

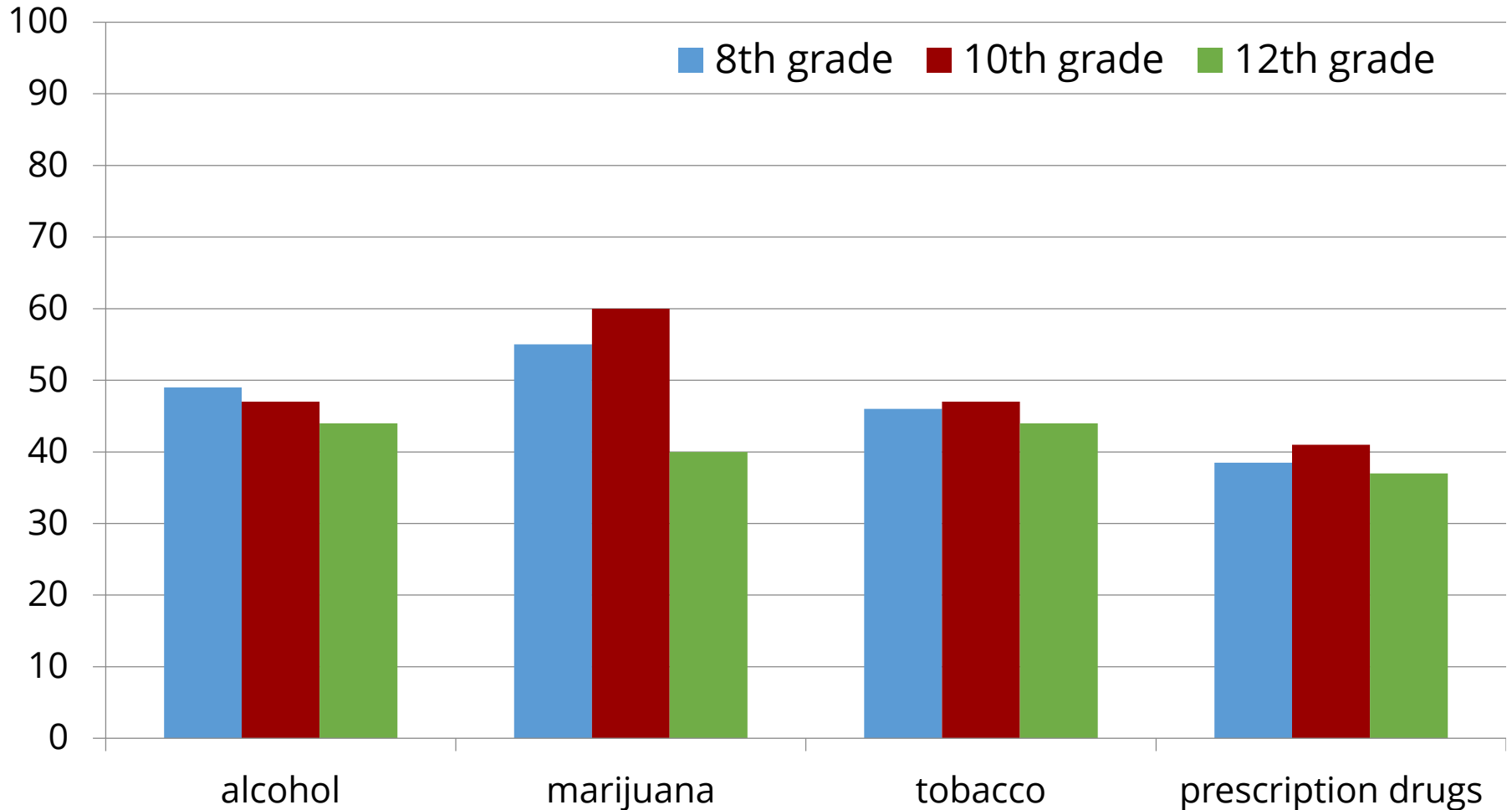
Perception of parental disapproval of use ; we want this to go up



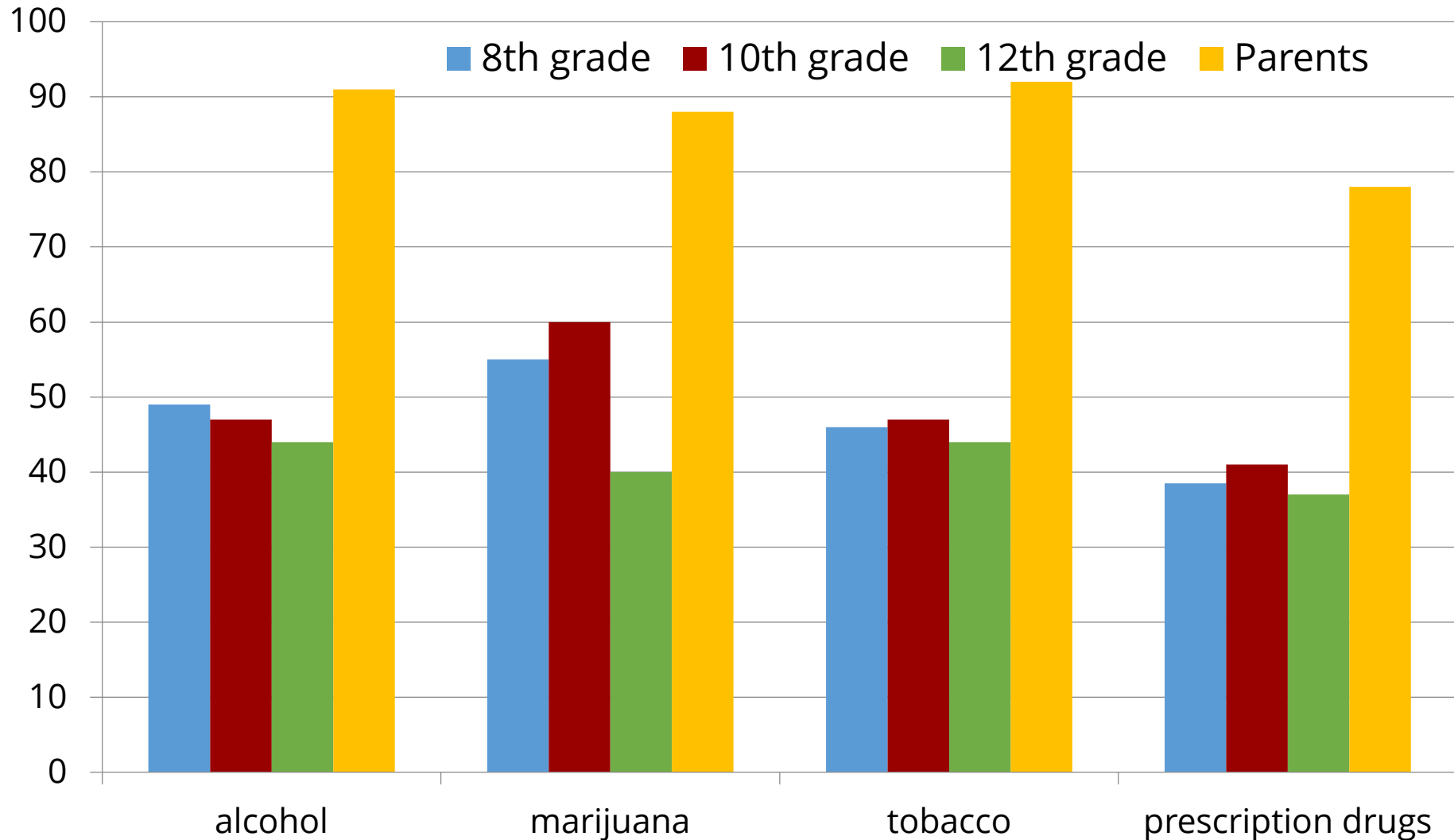
Perception of peer disapproval of use; we want this to go up



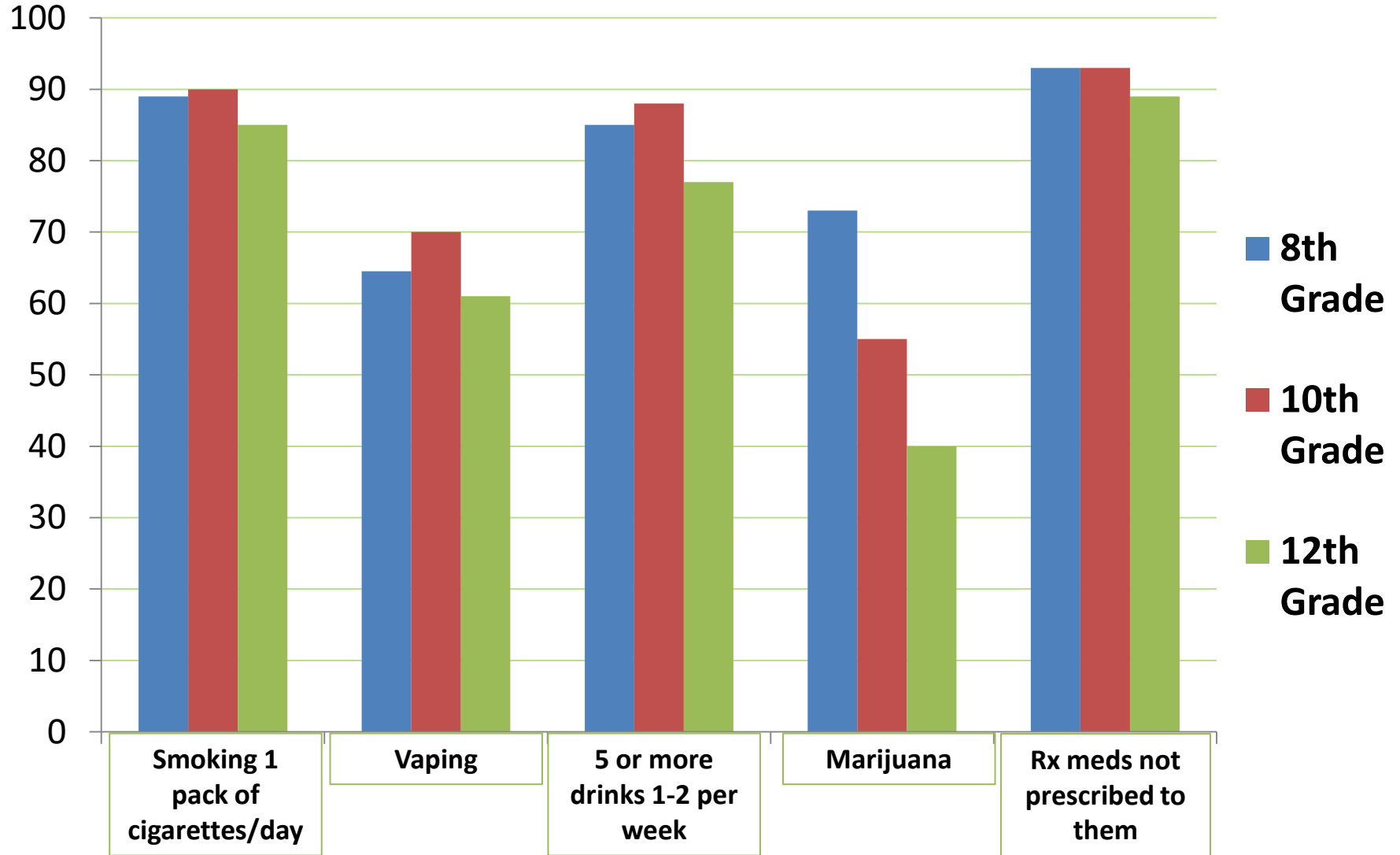
Percentage of students who report having talked with their parents or guardians about substances in past 12 months?



Percentage of parents or guardians who report talking with their child about substances in past 12 months?

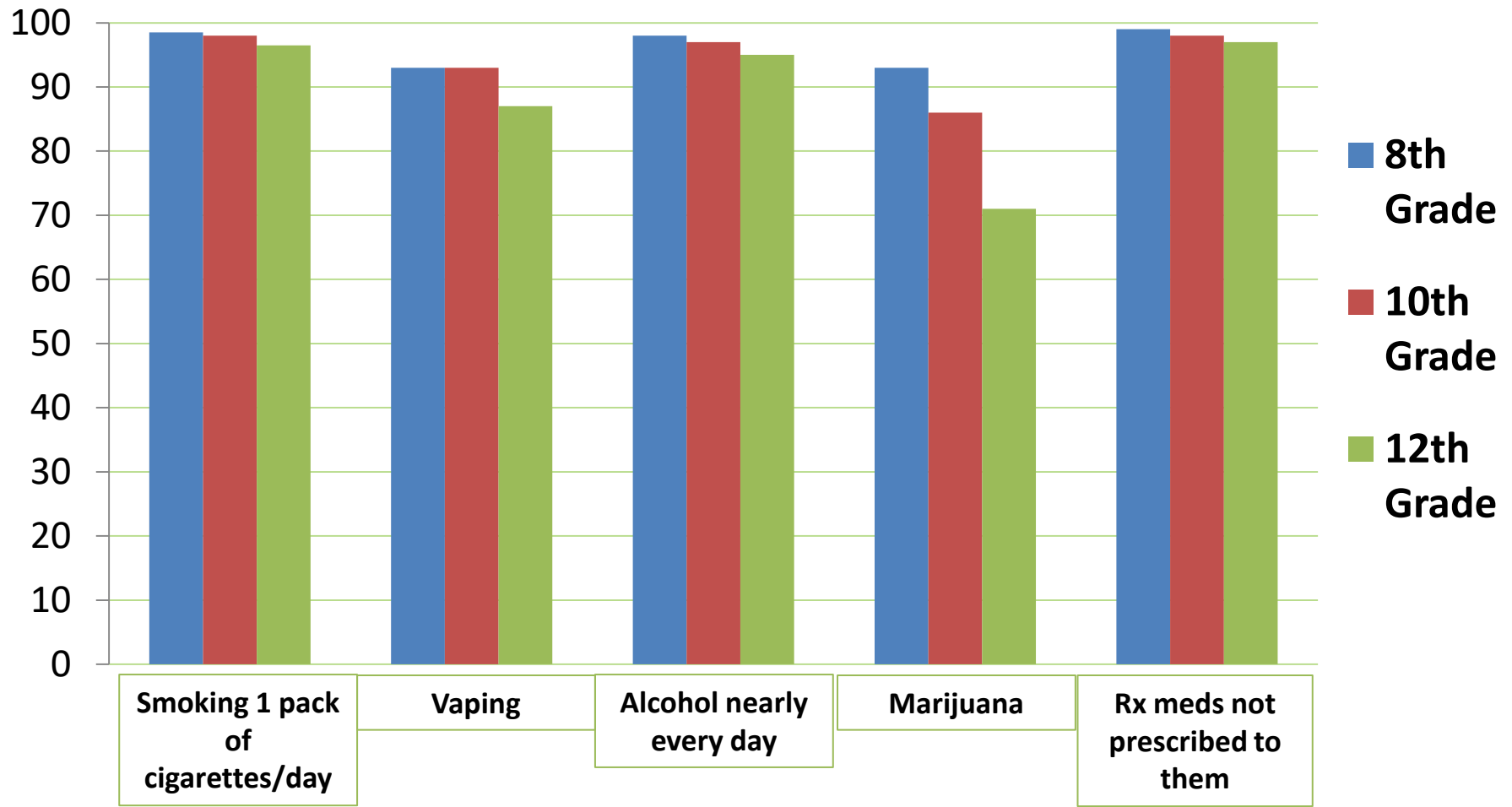

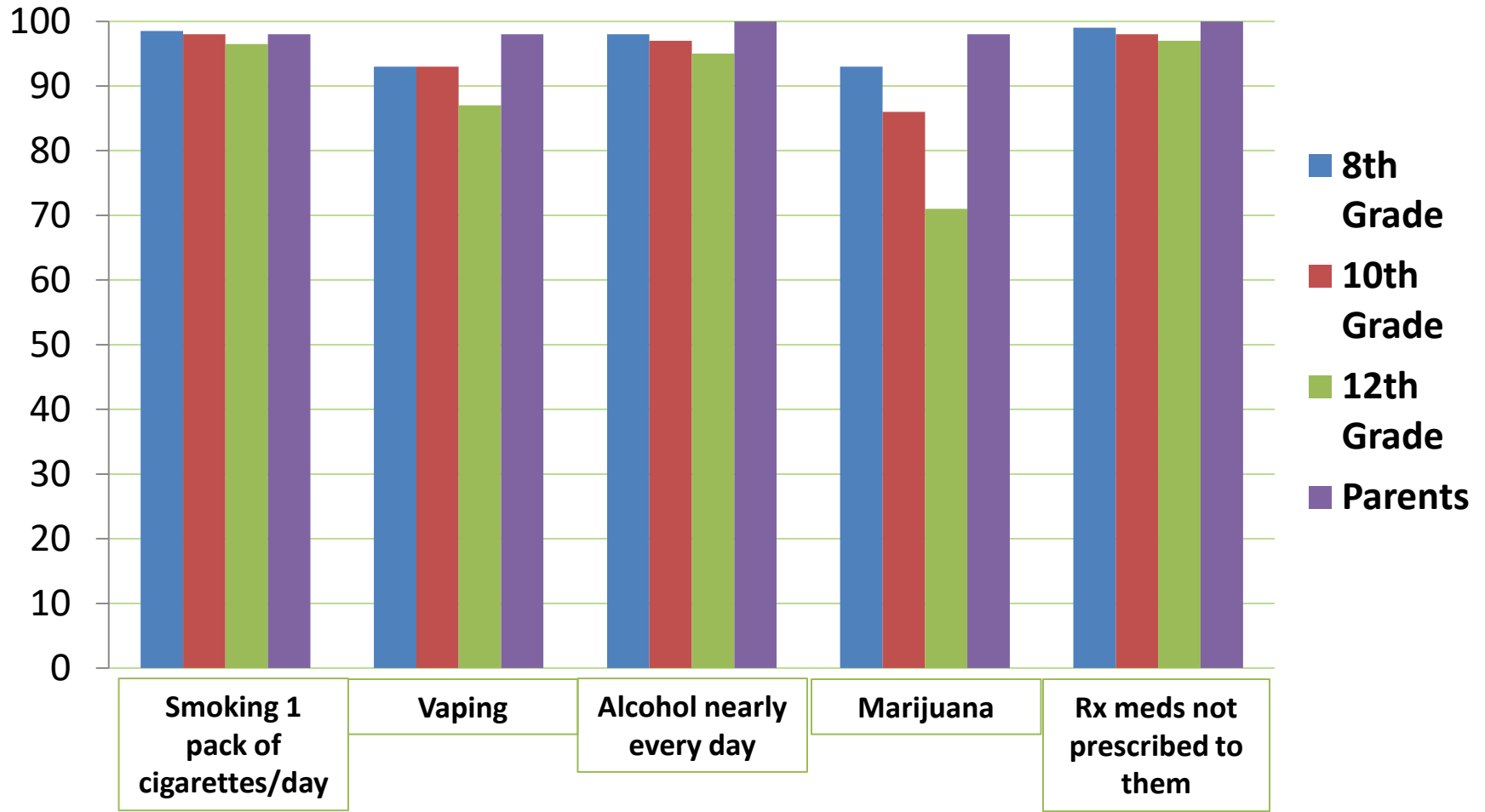
How much do people risk harming themselves if they...(“moderate” + “great risk”)

Students' perceptions – how *wrong* do my parents feel it is for me?

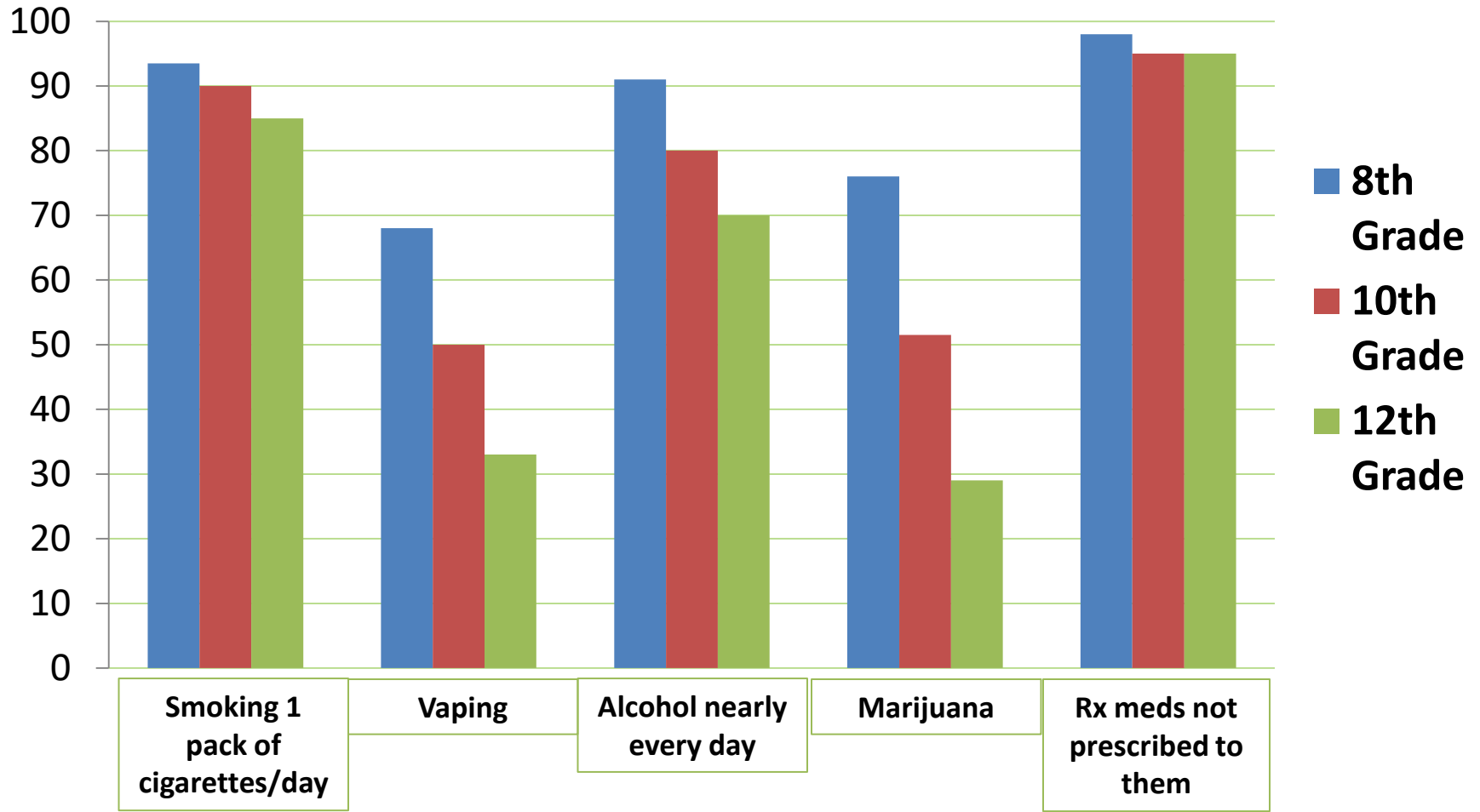


How wrong do your parents feel it would be for you to... (“wrong” + “very wrong”)

How wrong do parents feel it is for youth to:

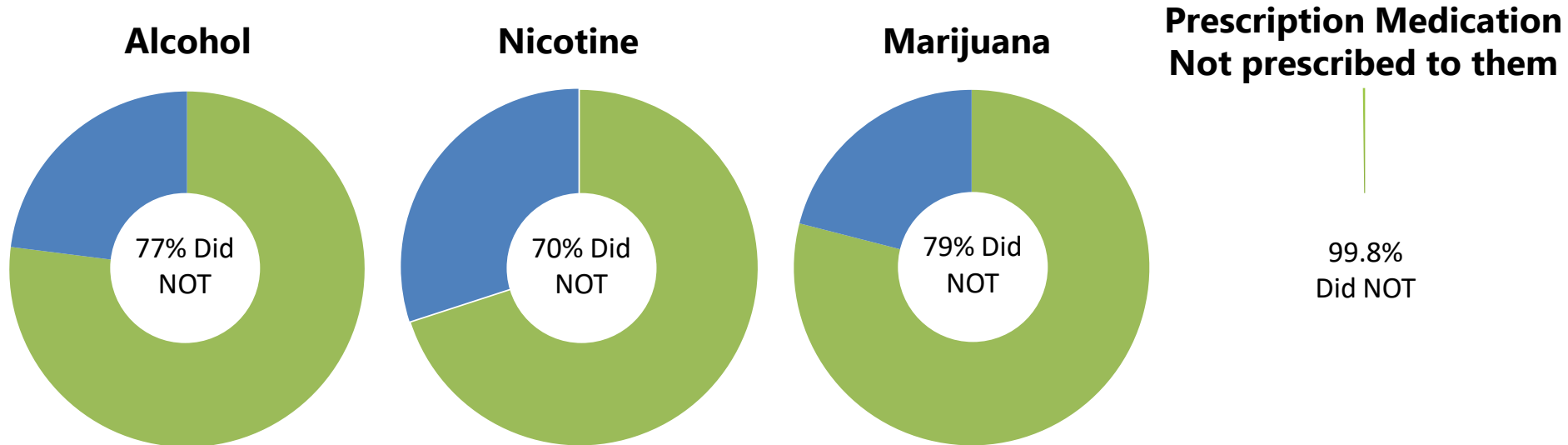


Students' perceptions – how wrong do my *friends feel* it is for me?



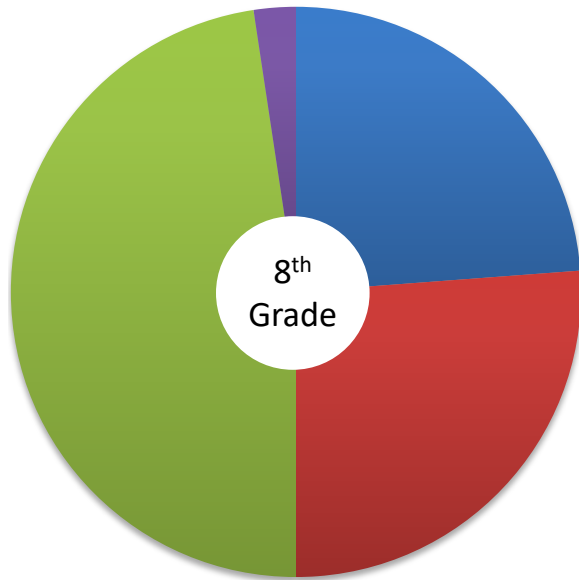

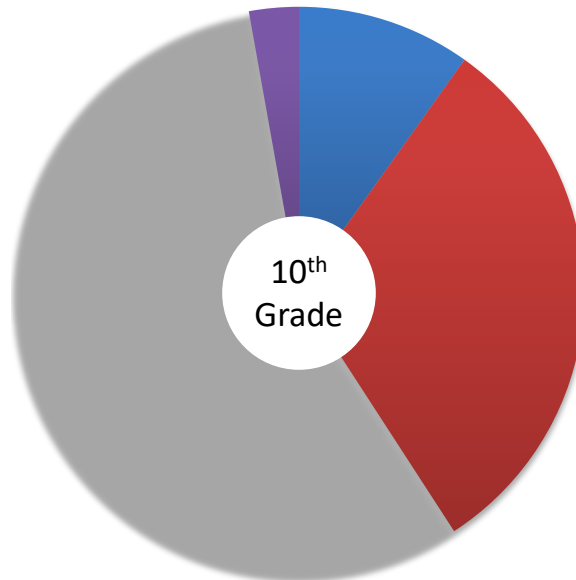

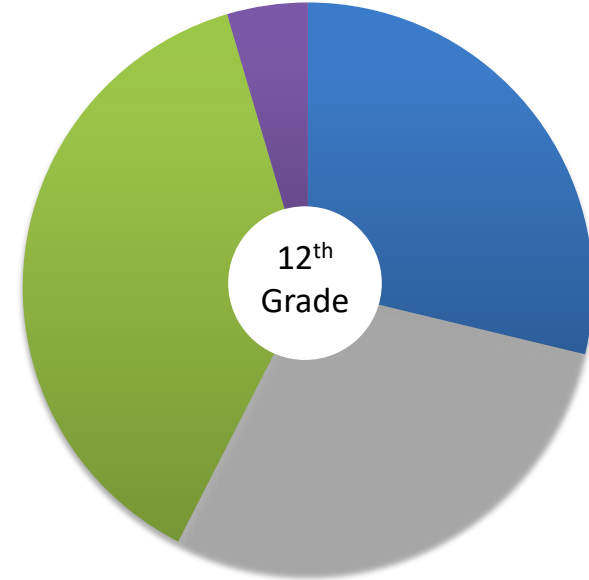

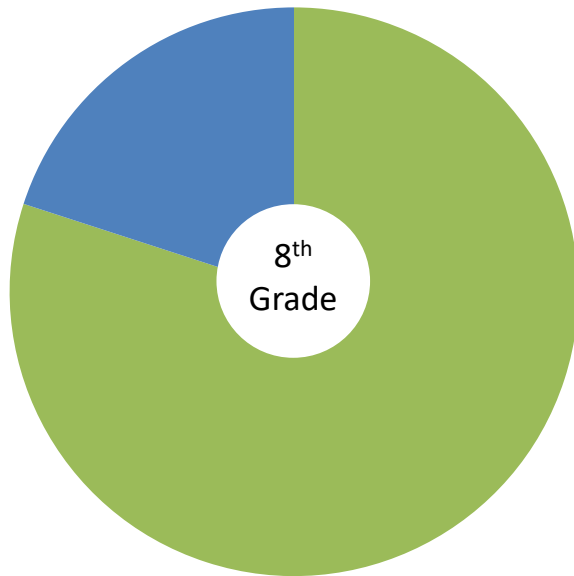

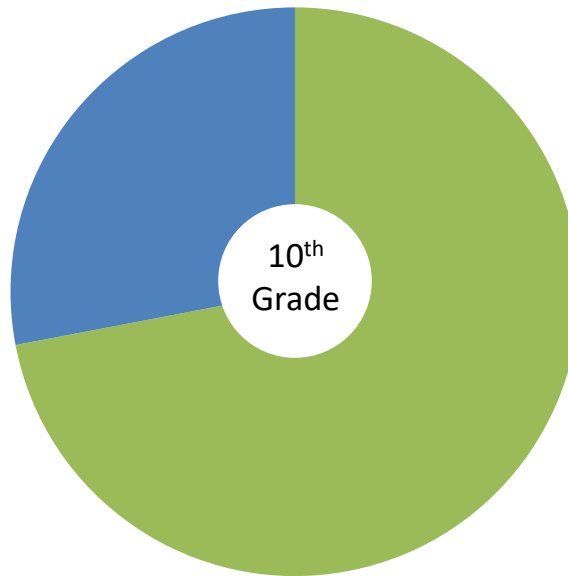


Past 30-day Vaping Use Combined Quaboag Hills Region



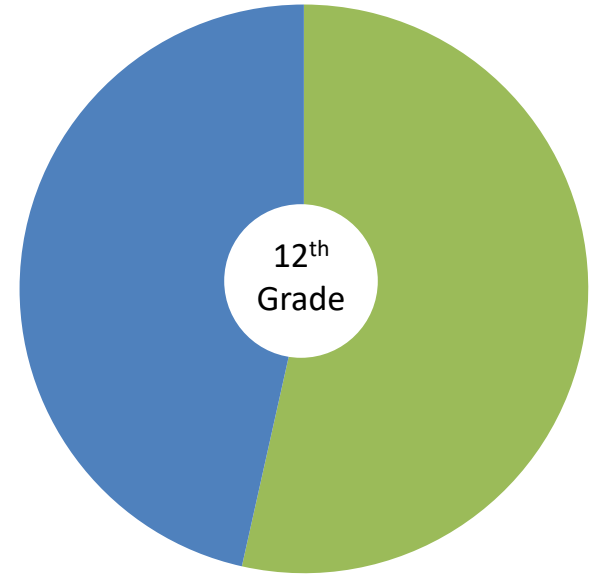

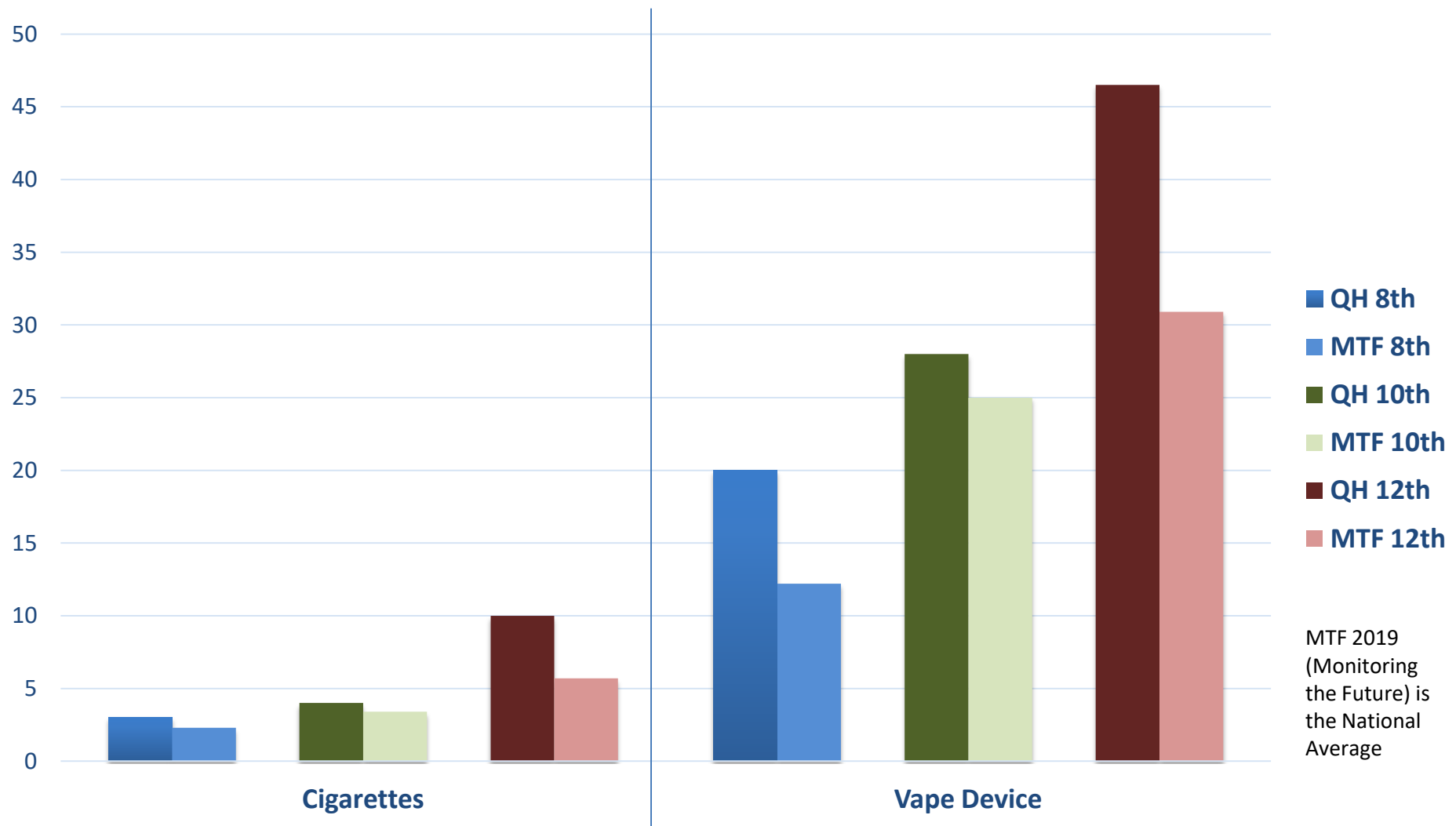

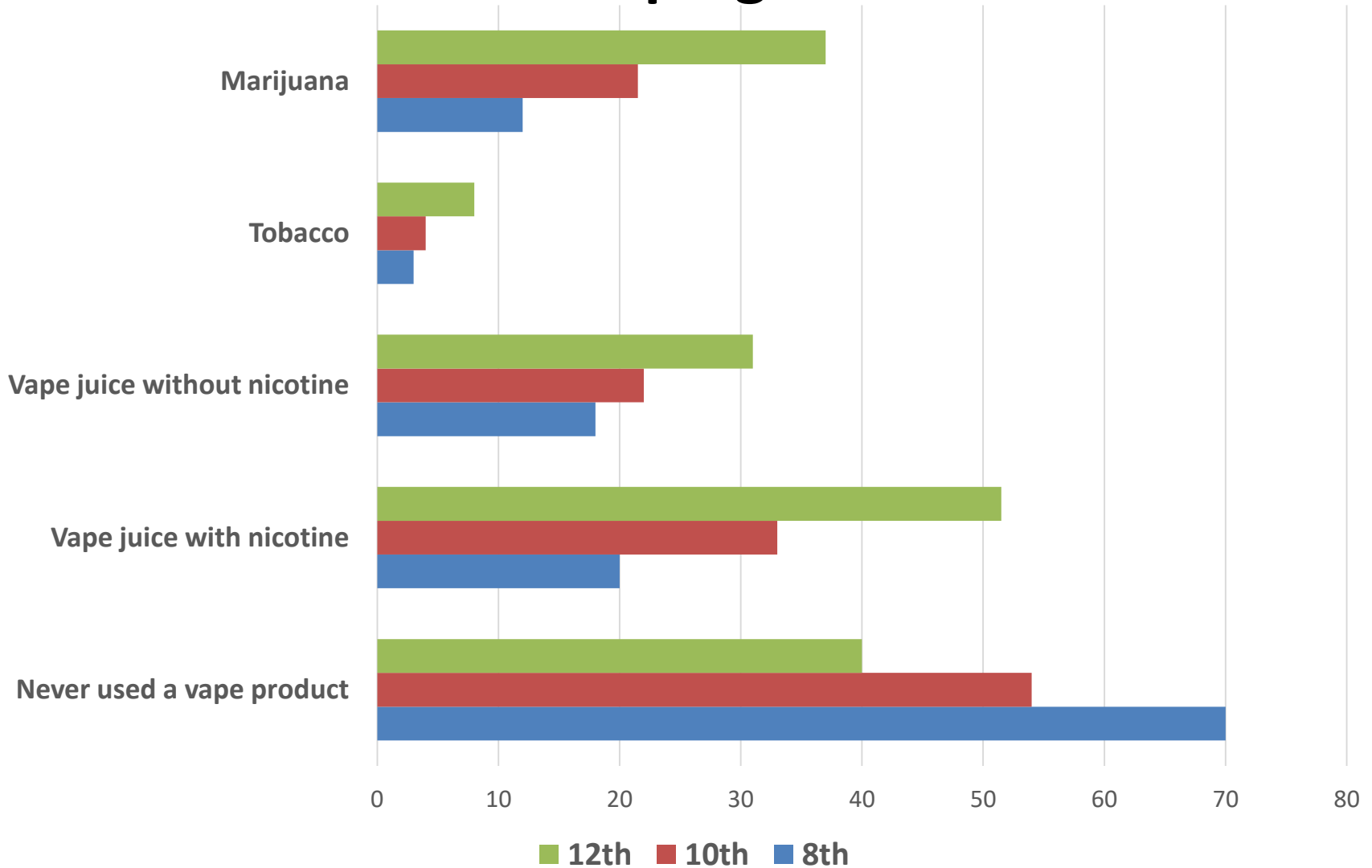

E-Cigarettes (vaping) vs. cigarettes; past 30-day use in our region and the nation

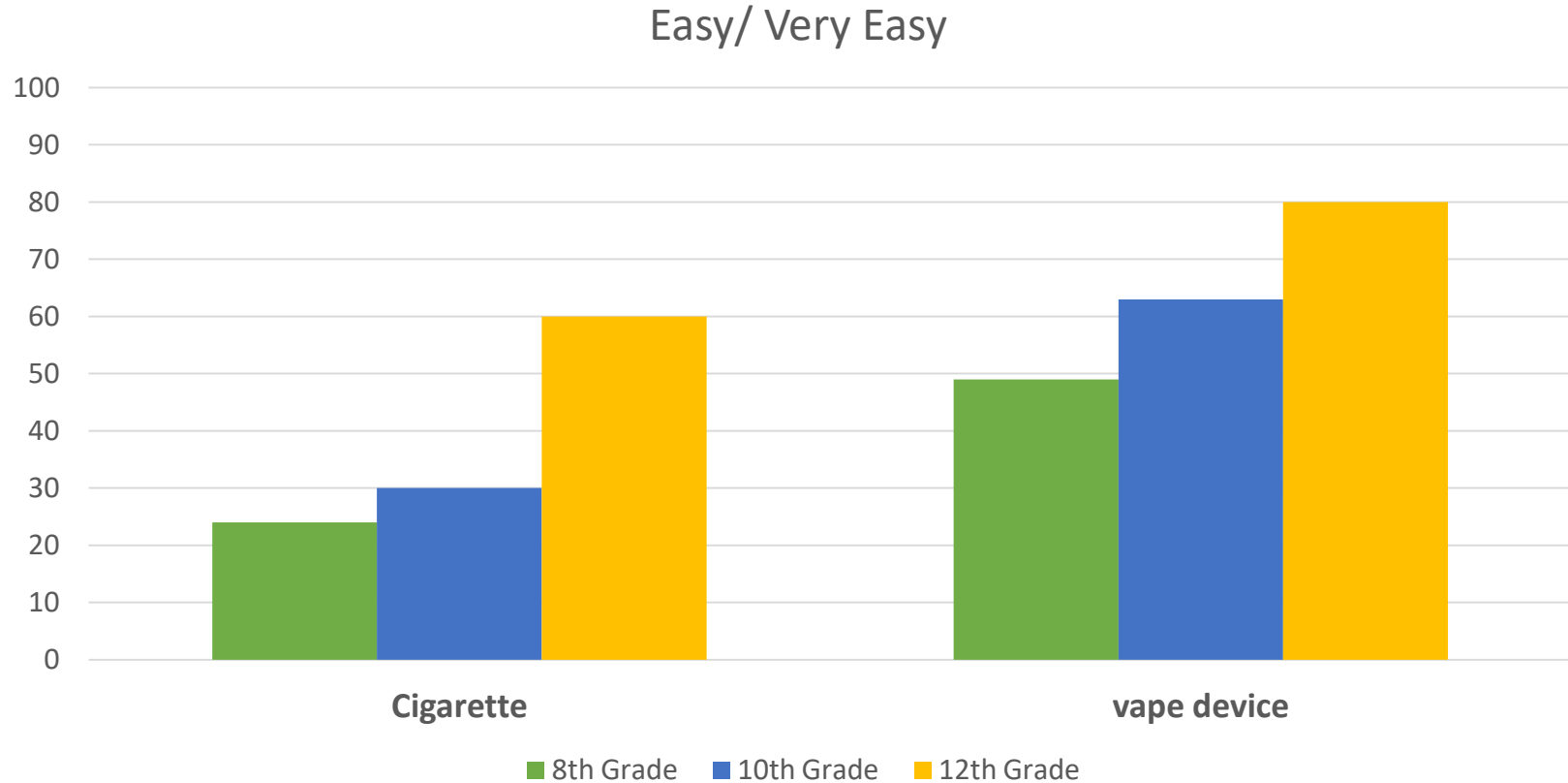

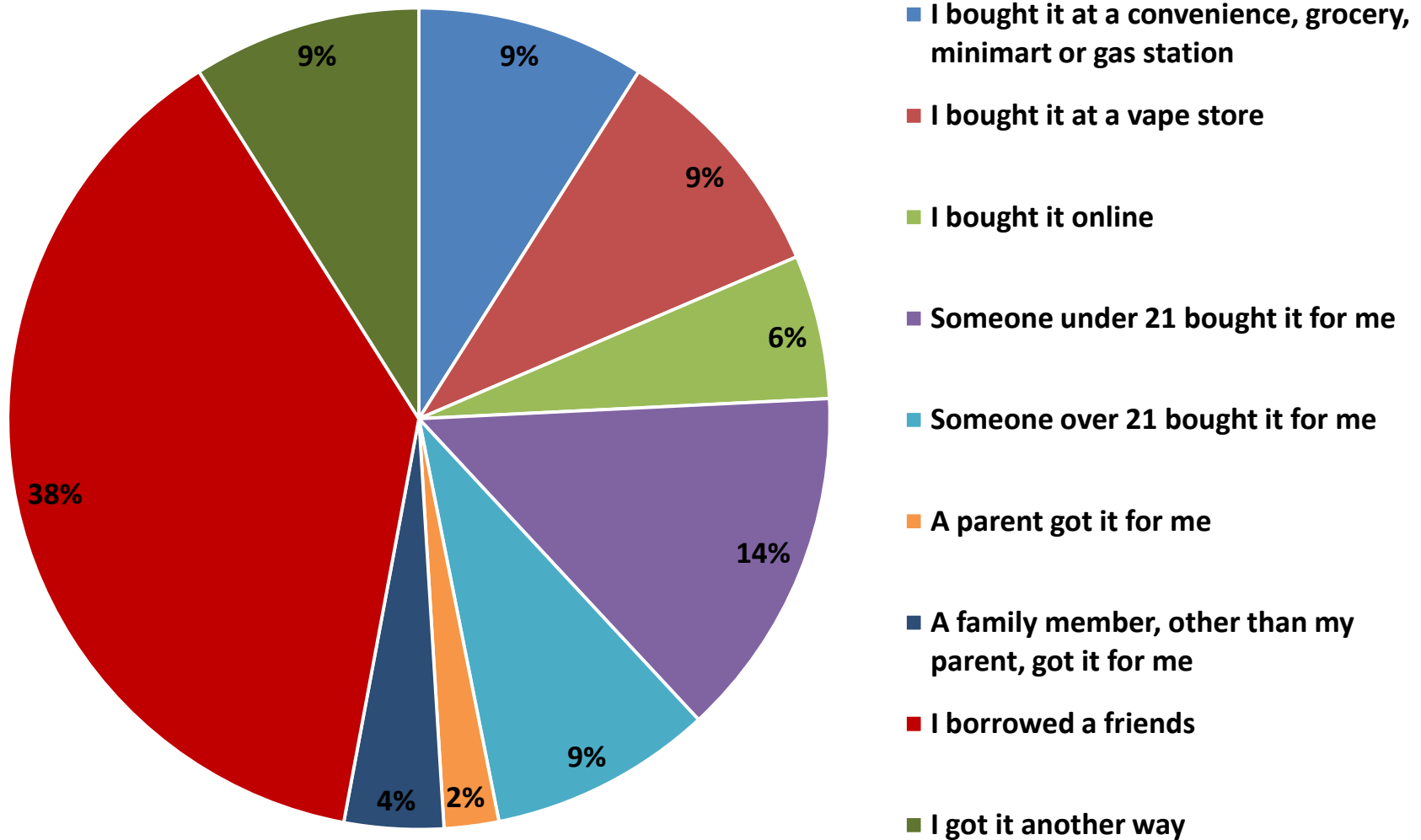


If you wanted to get cigarettes, how easy would it be for you to get some?

If you wanted to get an e-cigarette, JUUL, vape pen or other electronic vapor product, how easy would it be for you to get one?



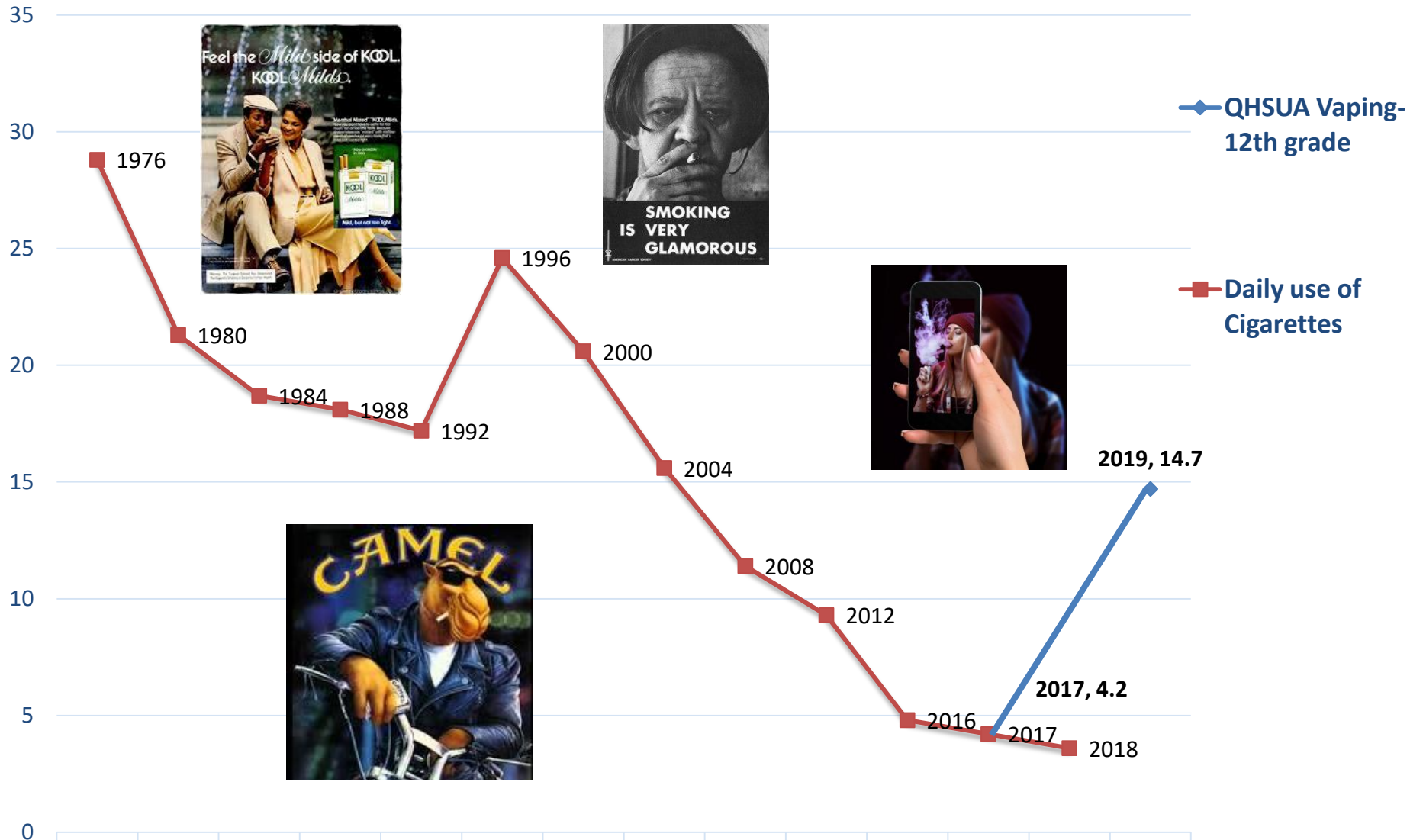

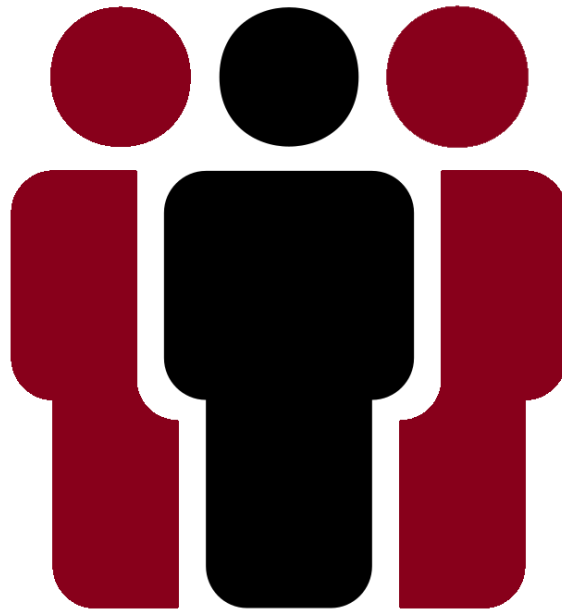

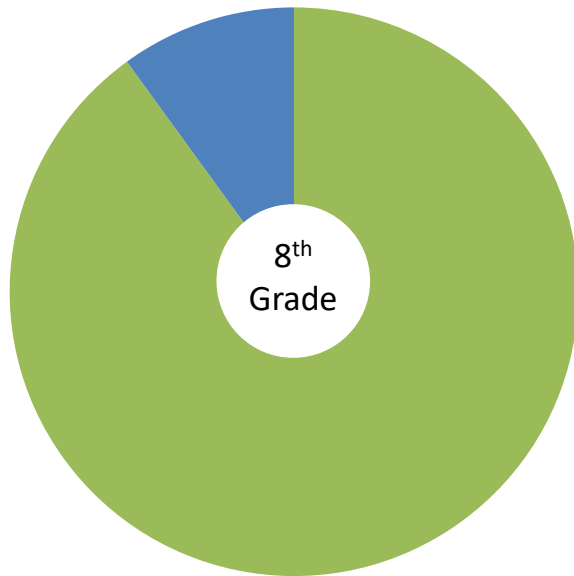

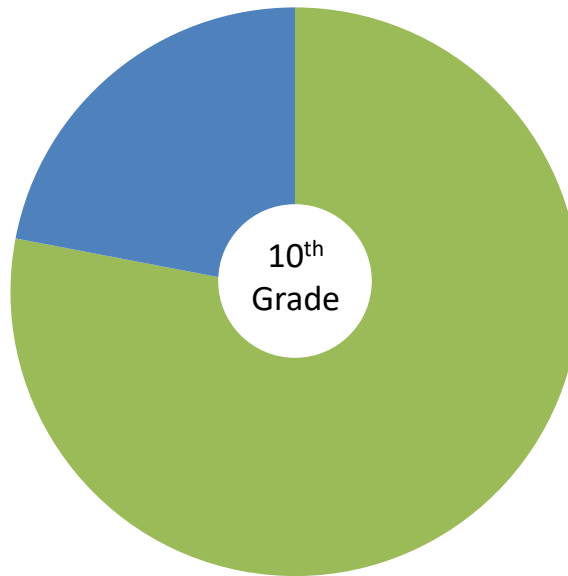

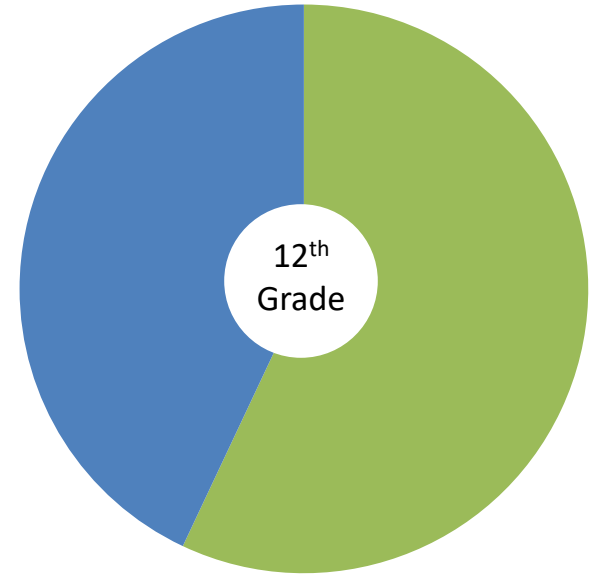

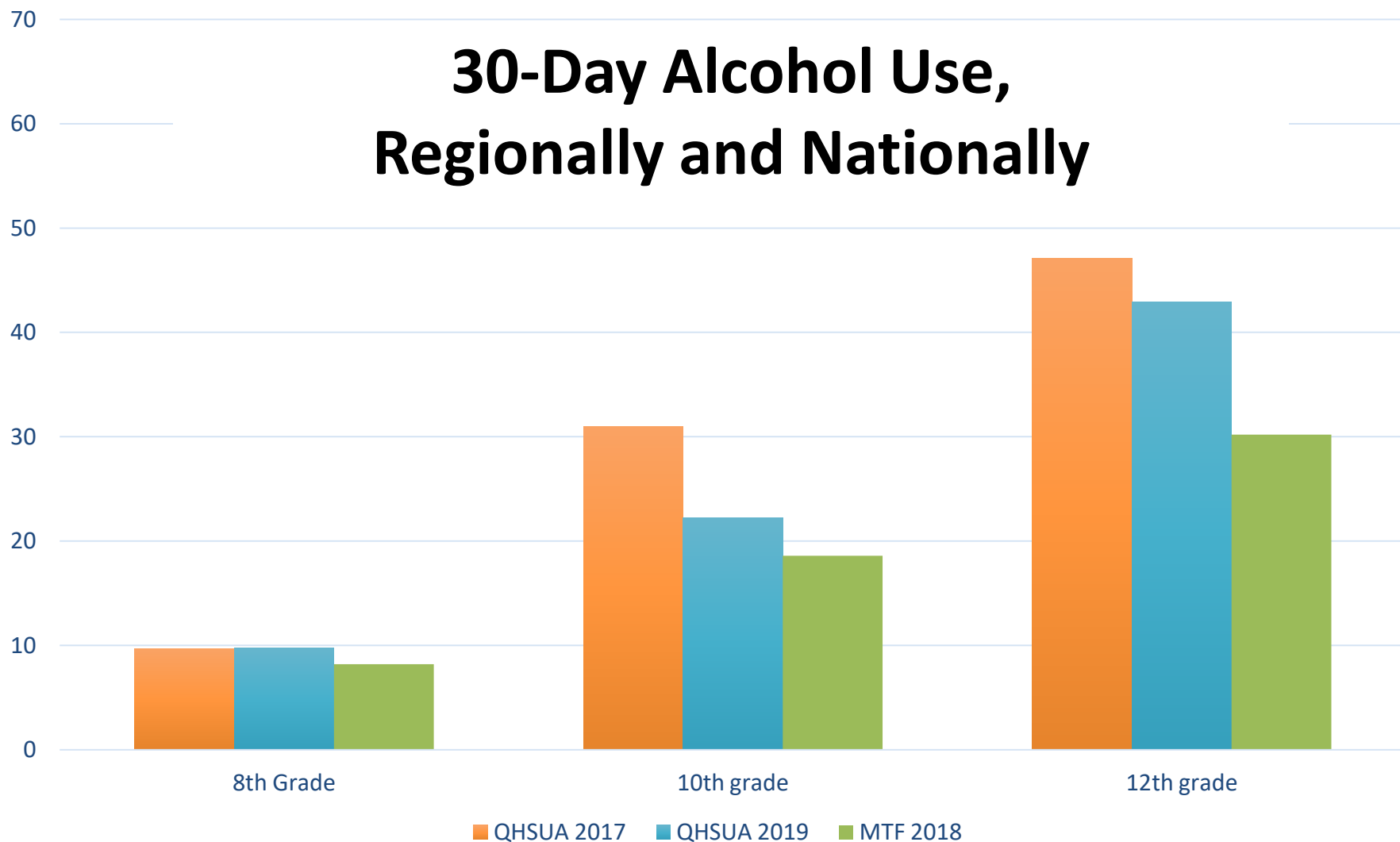

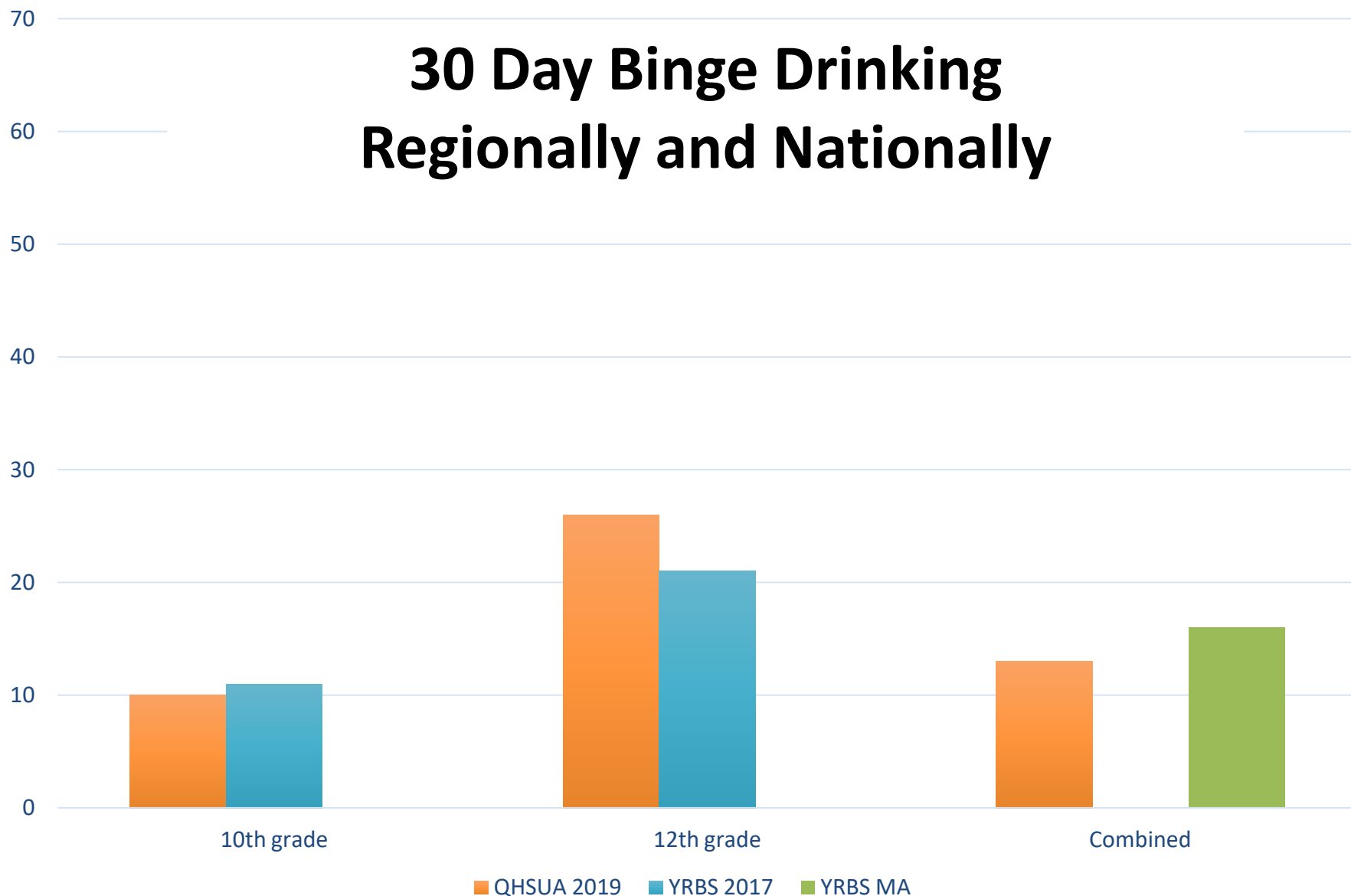
30-Day Alcohol Use, Regionally and Nationally

The 2018 Monitoring the Future (MTF) national survey shows a similar movement in terms of increasing rates of alcohol use as students age.

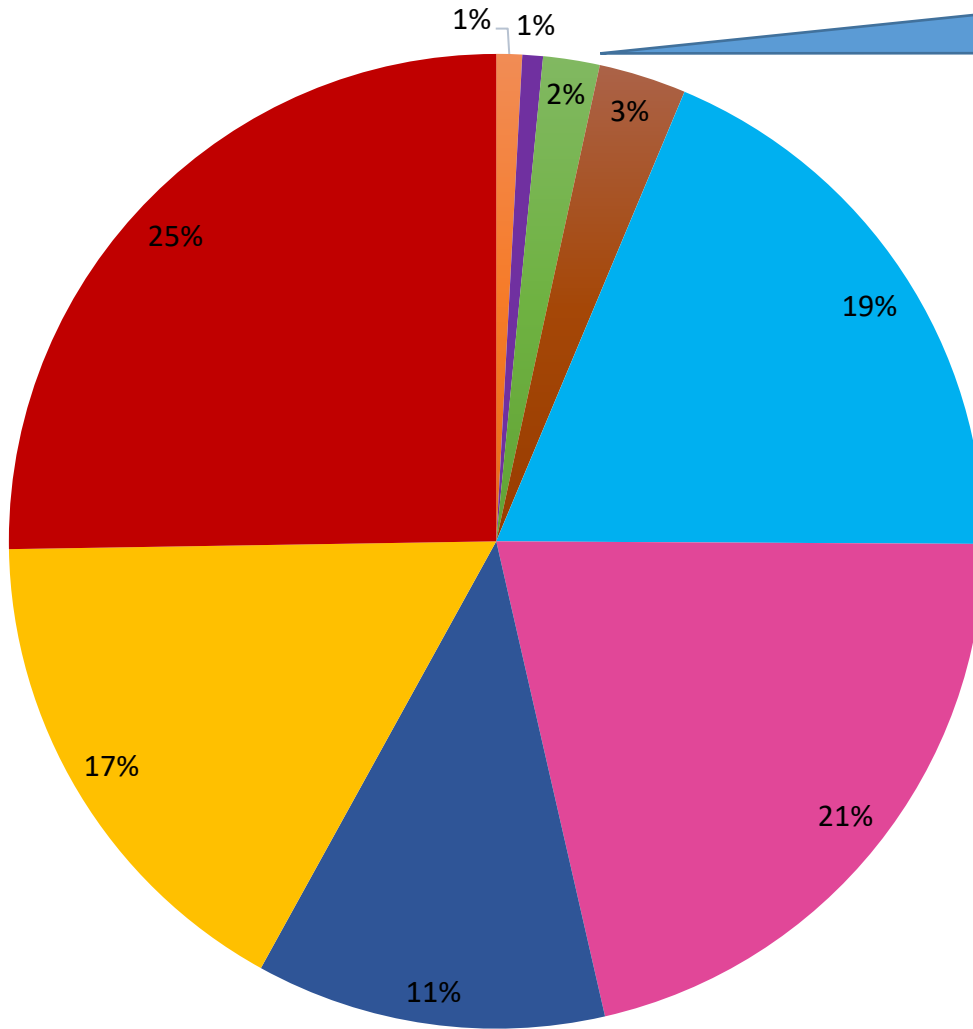
30 Day Binge Drinking Regionally and Nationally

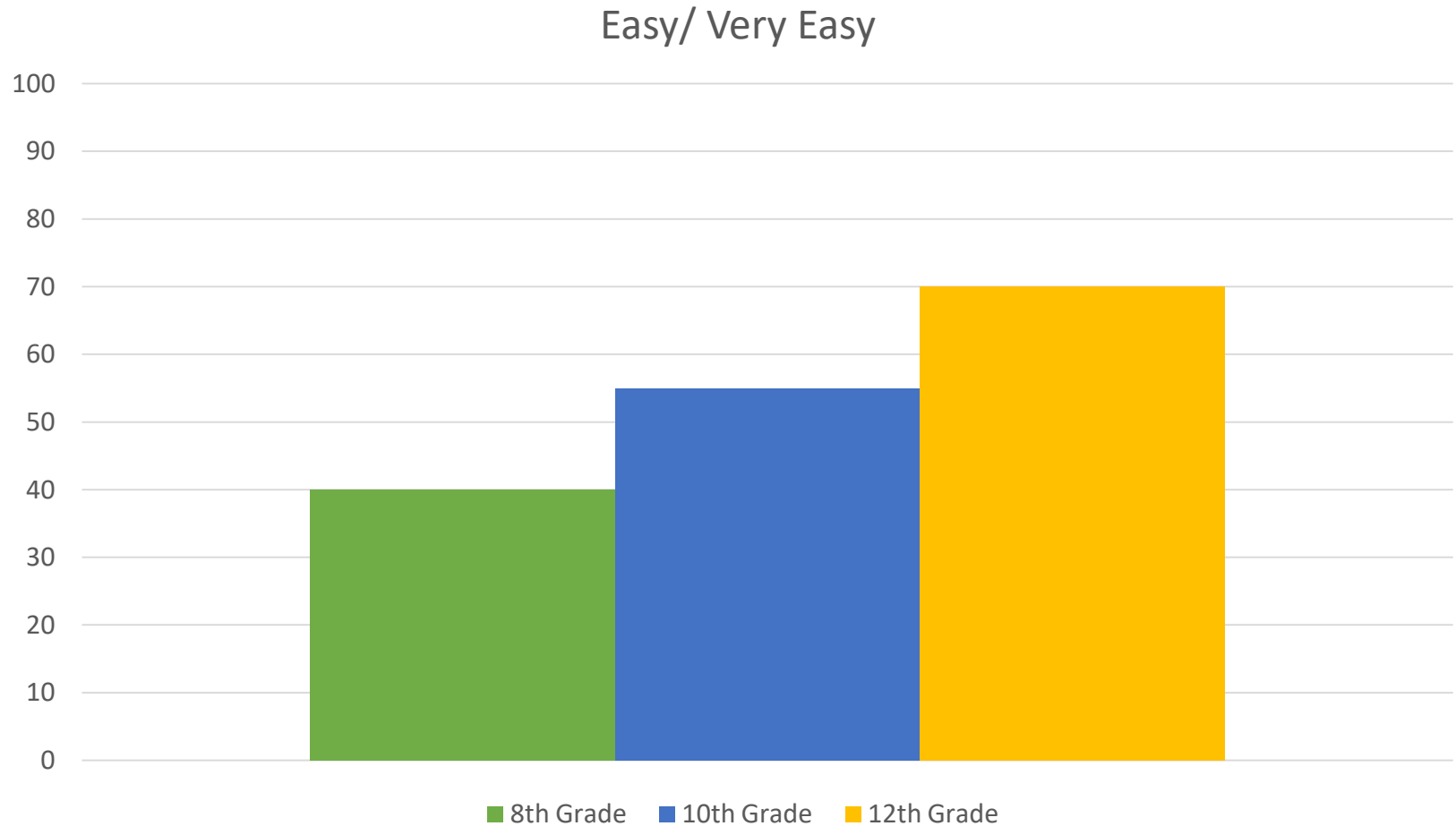

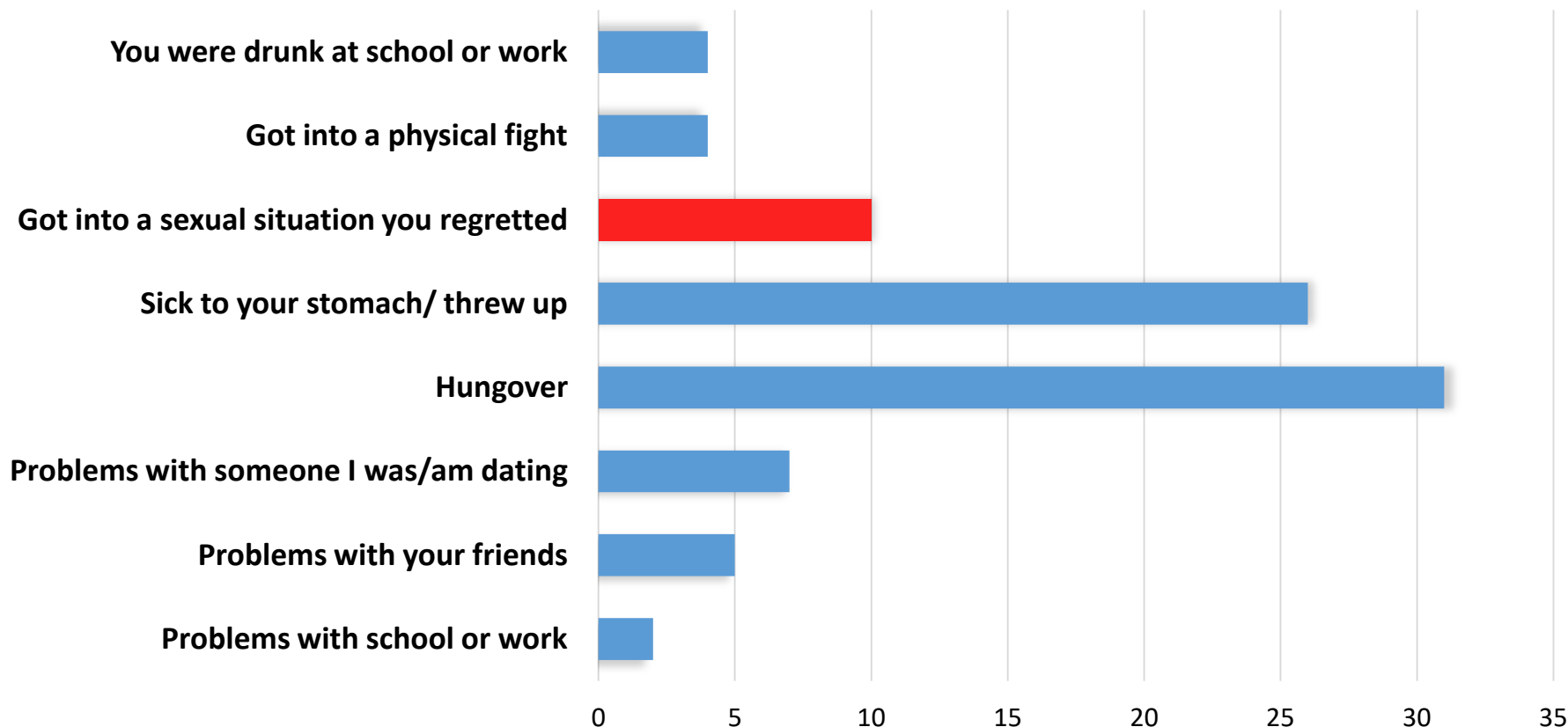

Worrisome Consequences of Alcohol Use among 12th Graders in the Quaboag Hills Region



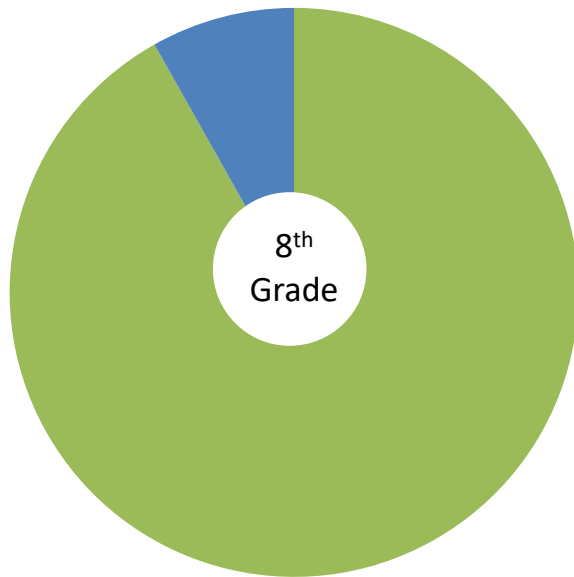

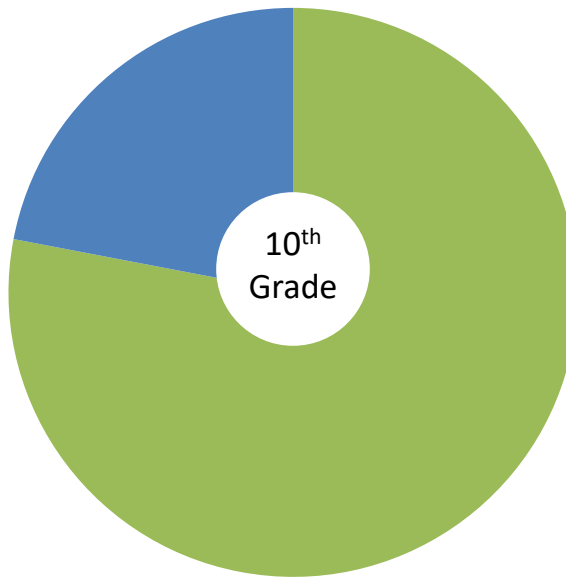

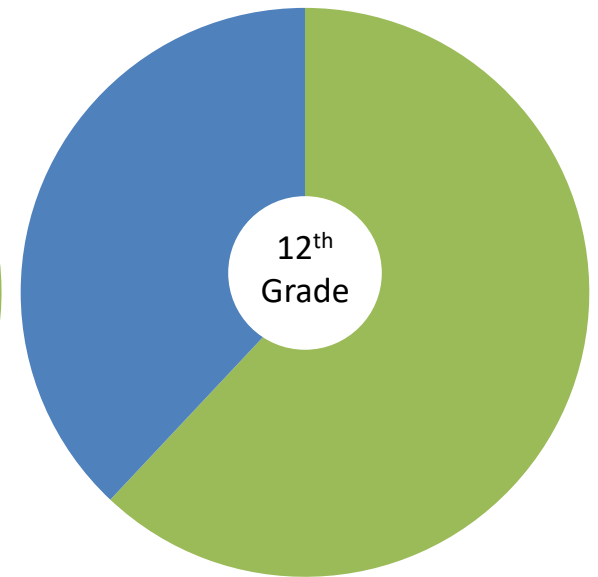

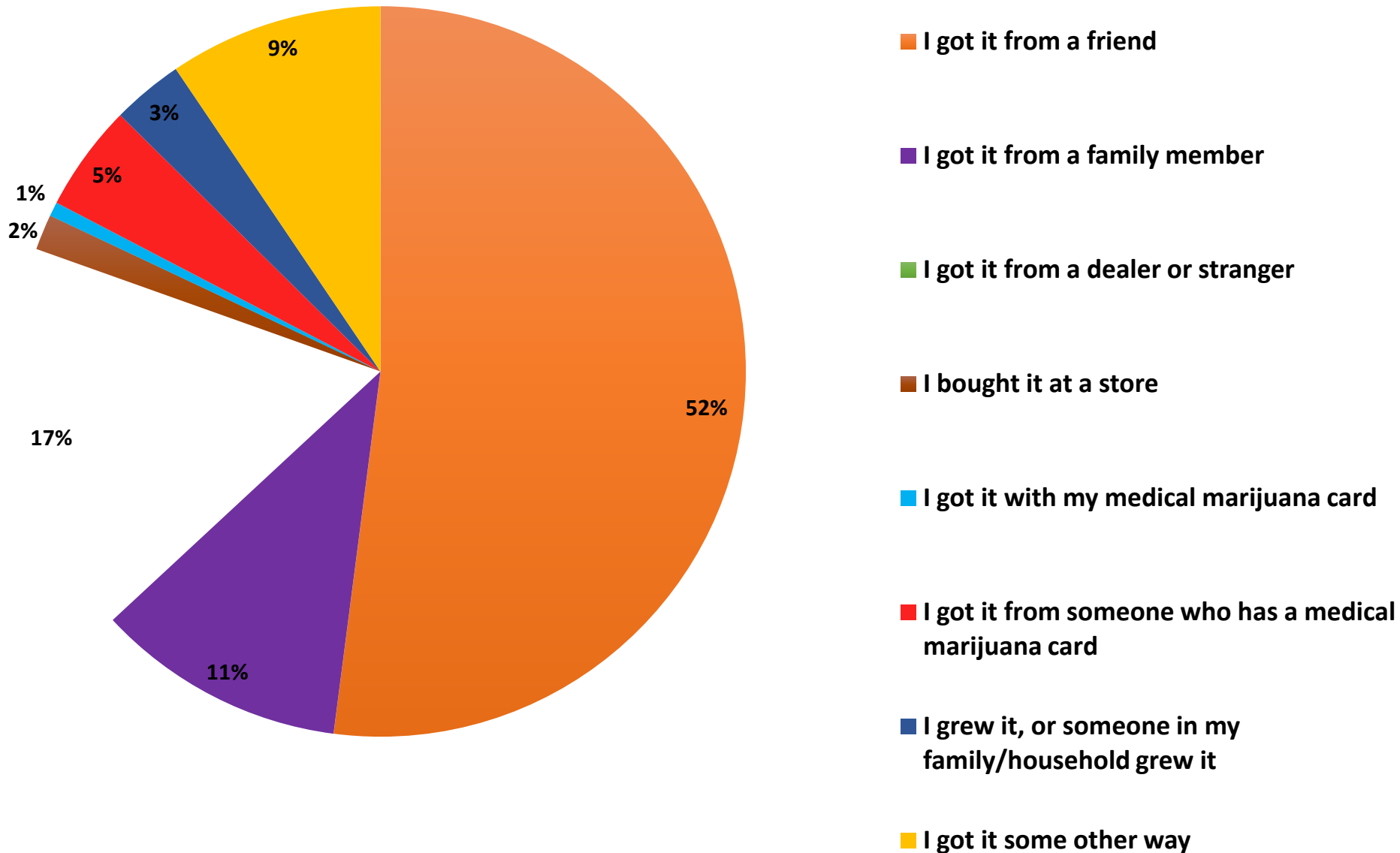

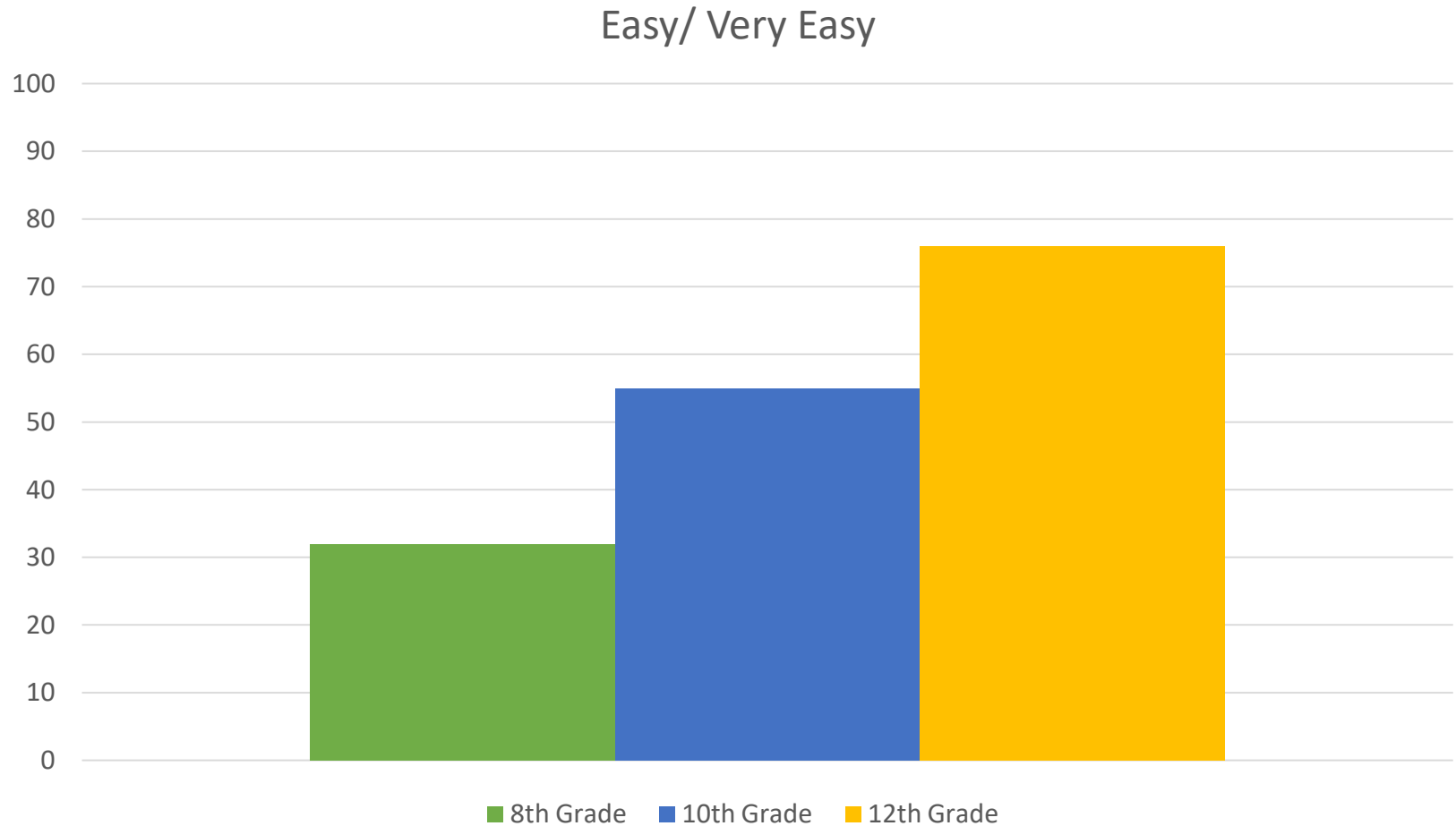

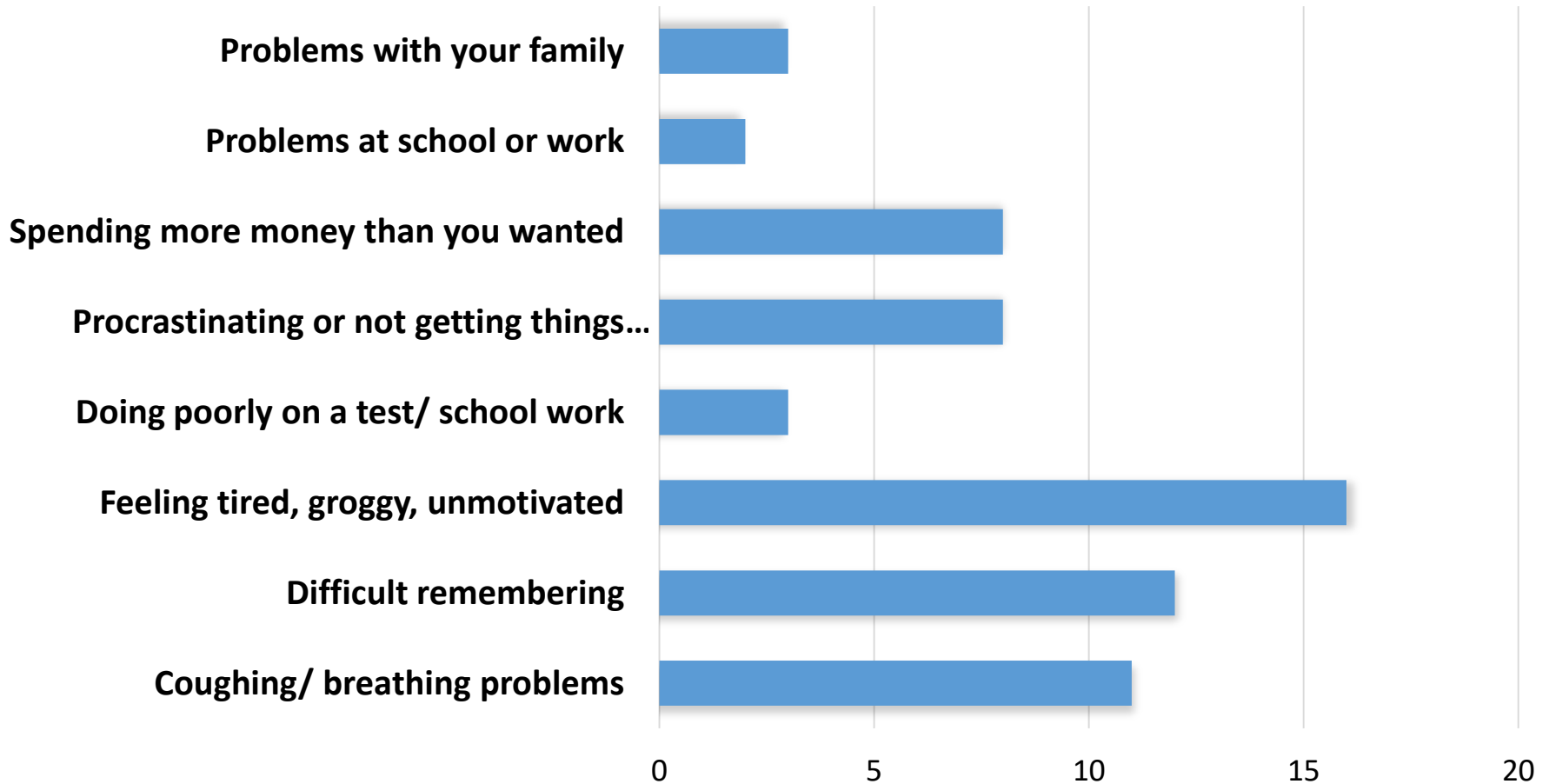

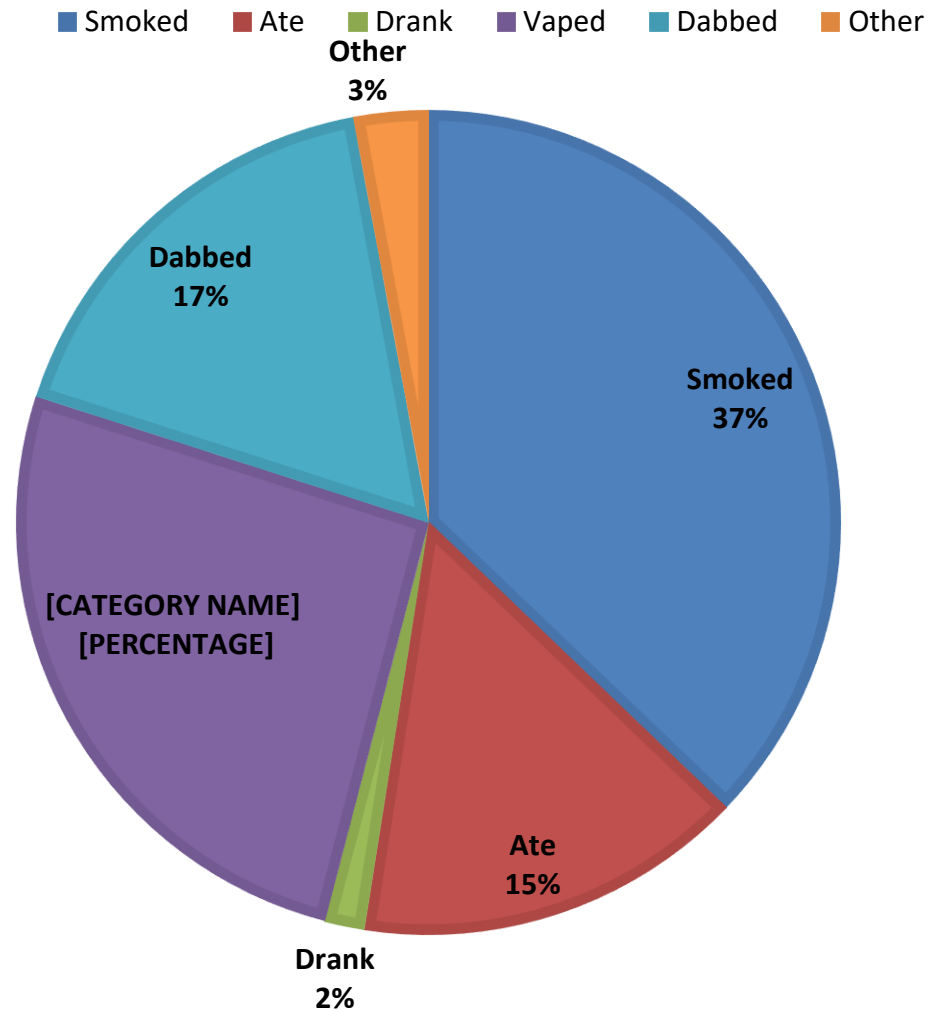


Worrisome Consequences of Marijuana Use among 12th Graders in the Quaboag Hills Region

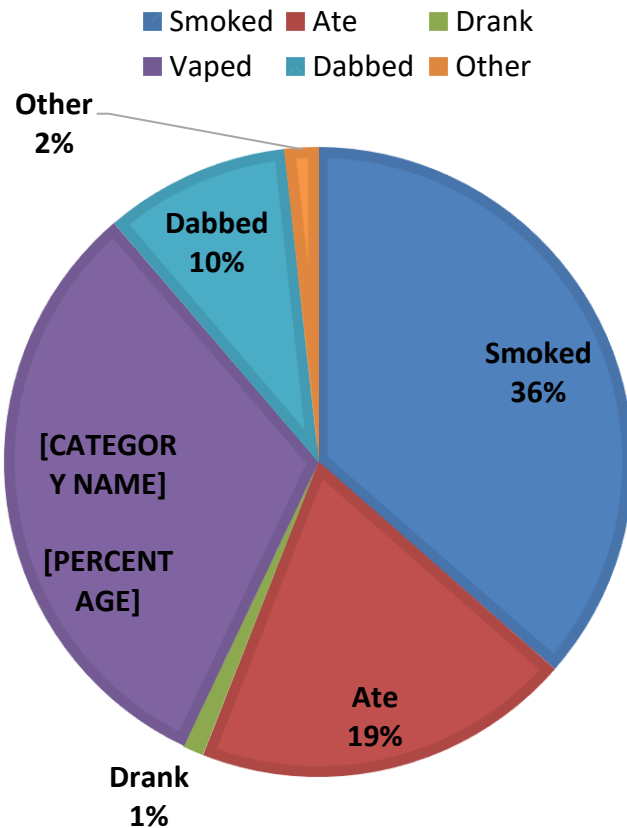

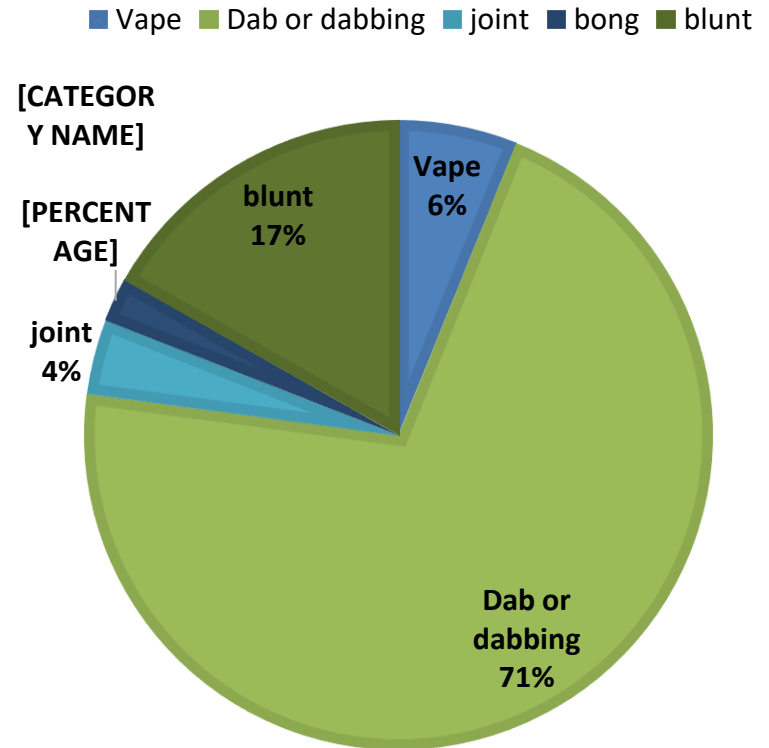
Parental understanding of current marijuana use by teenagers.

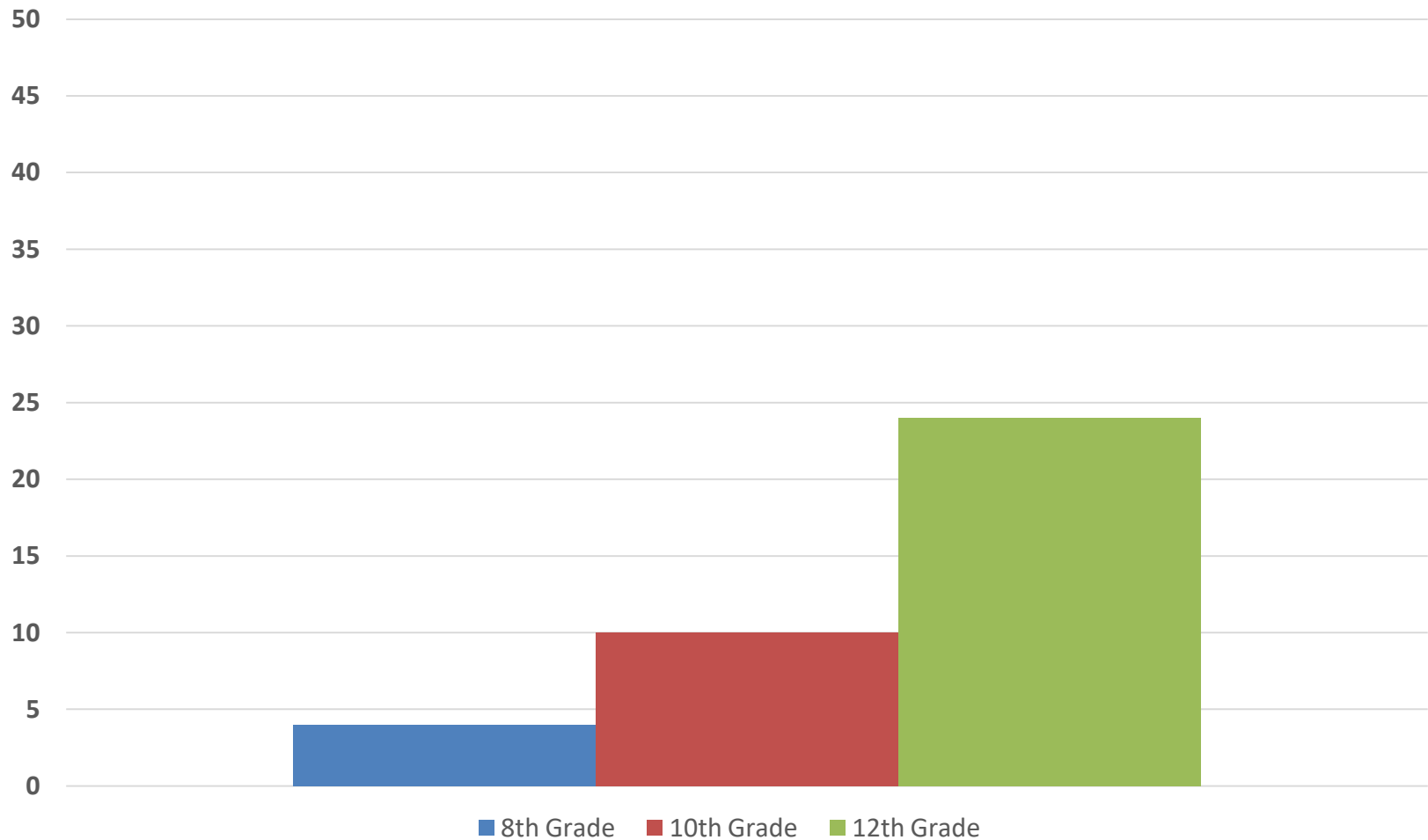
How do parents think marijuana is used by youth?

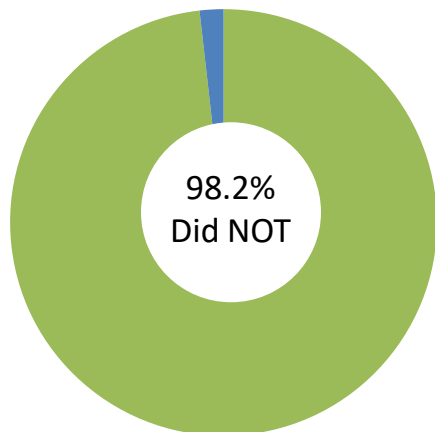

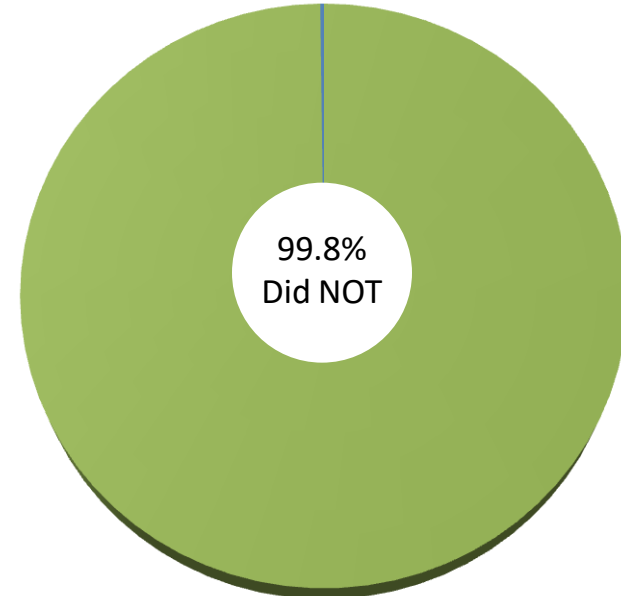

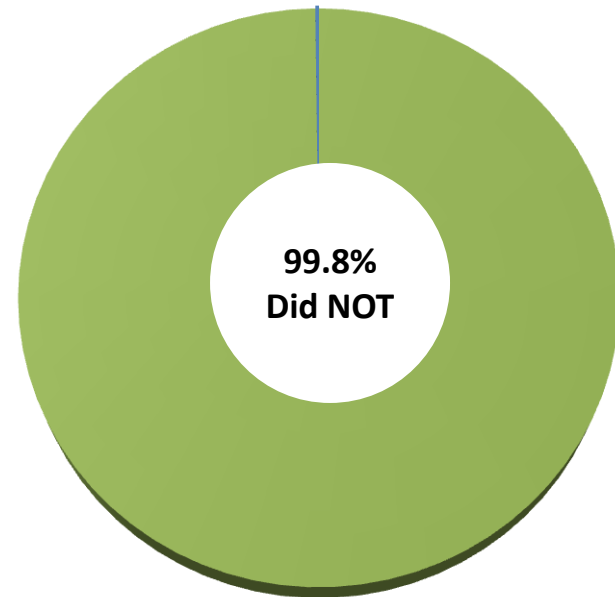

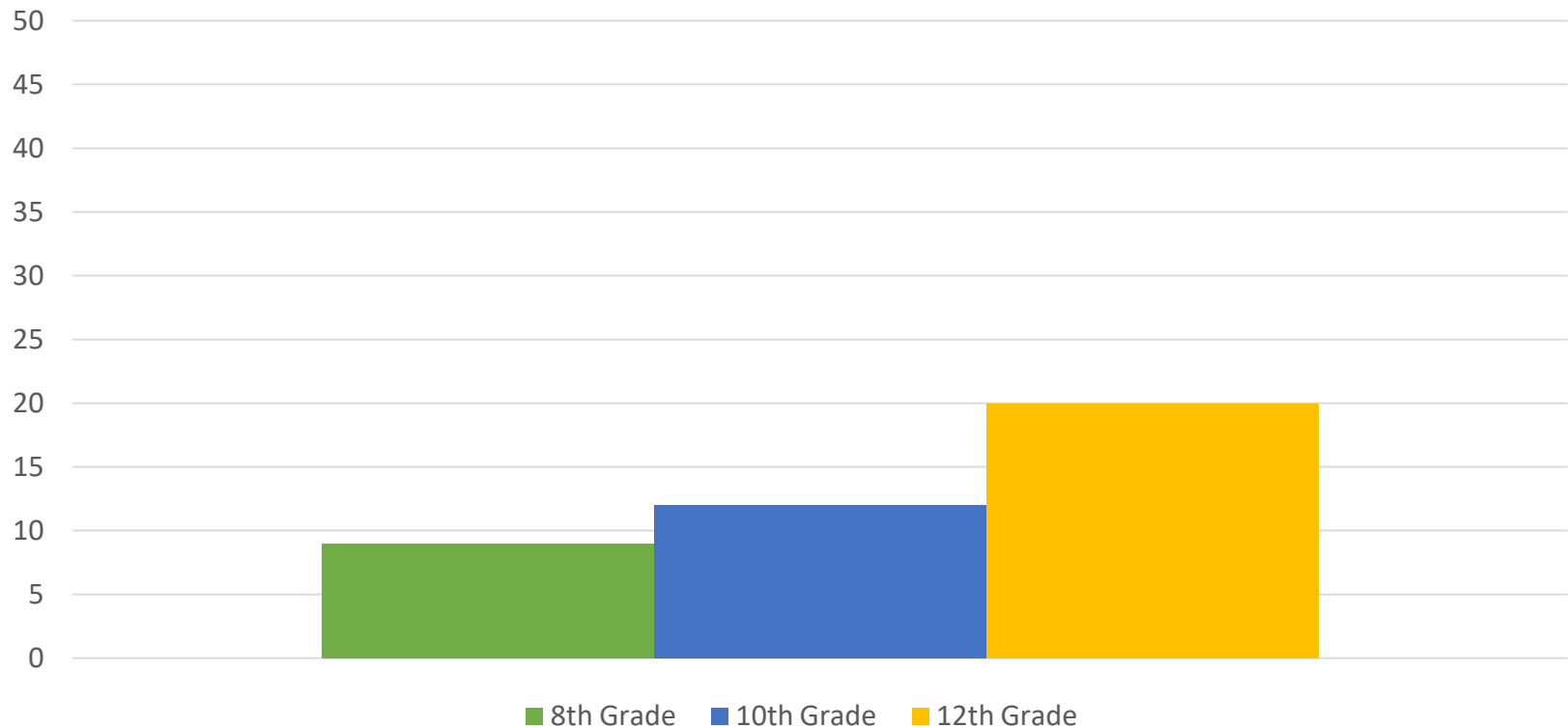

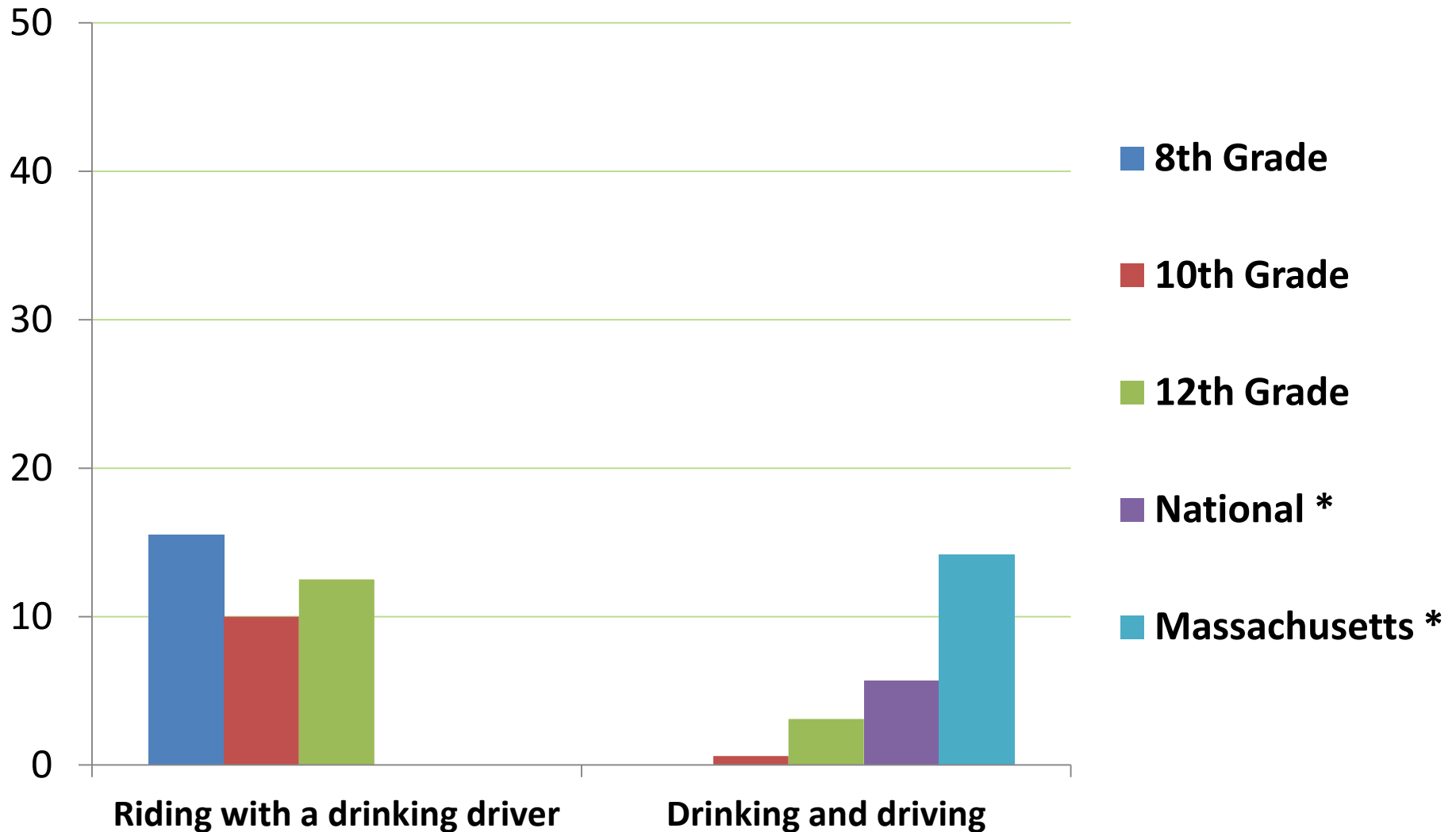

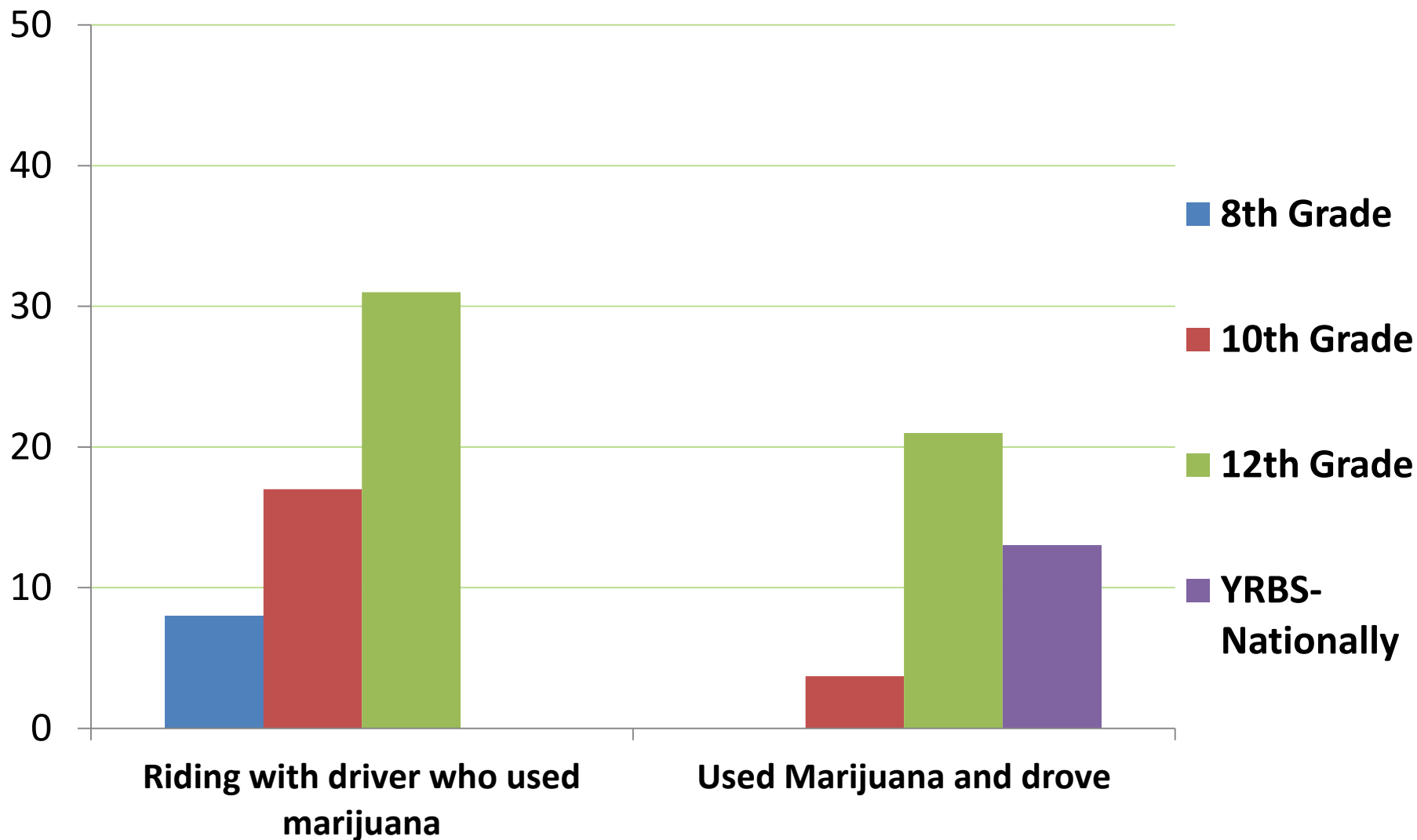


Drinking, Riding & Driving Past 30-day



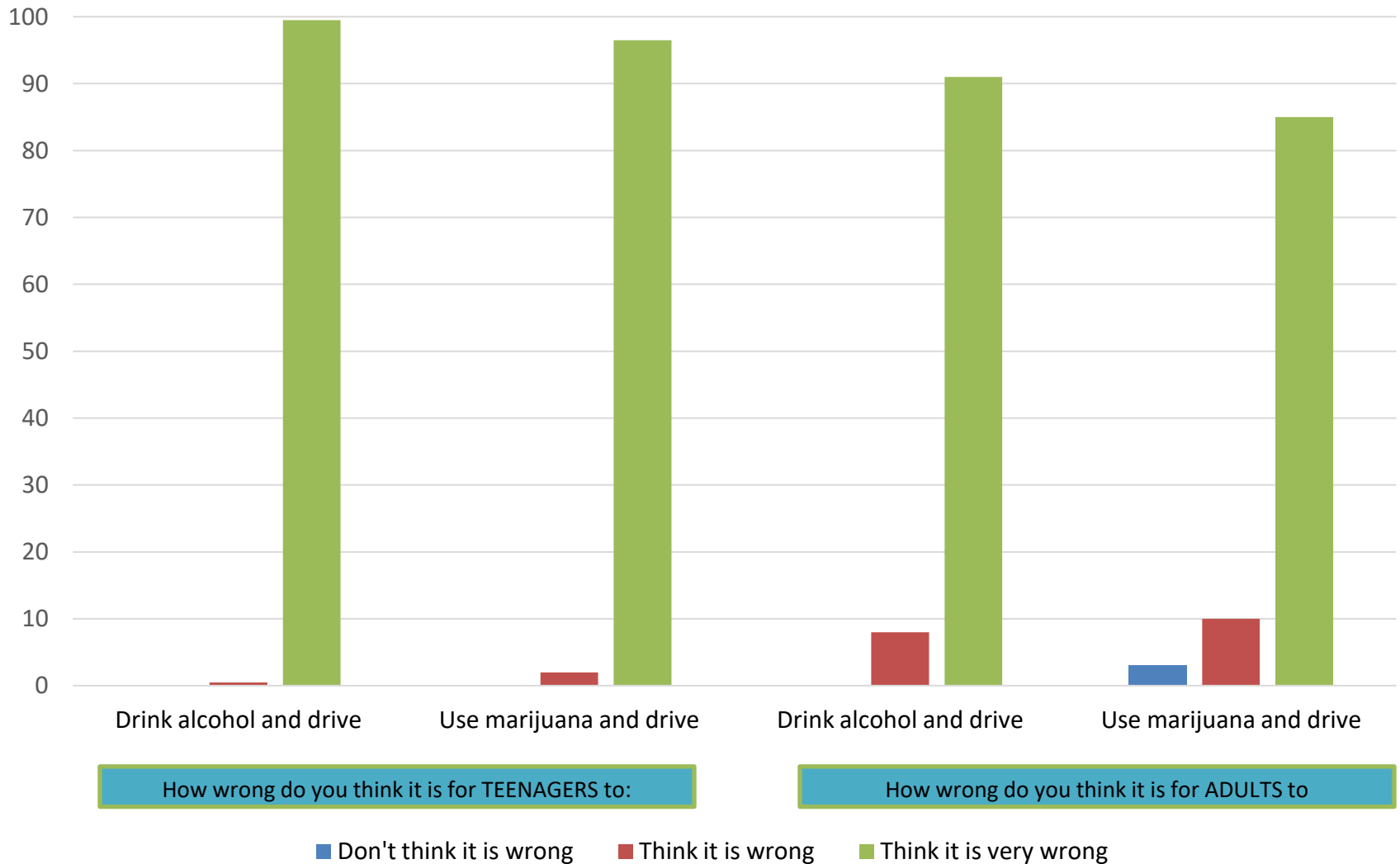

Marijuana Use, Riding & Driving



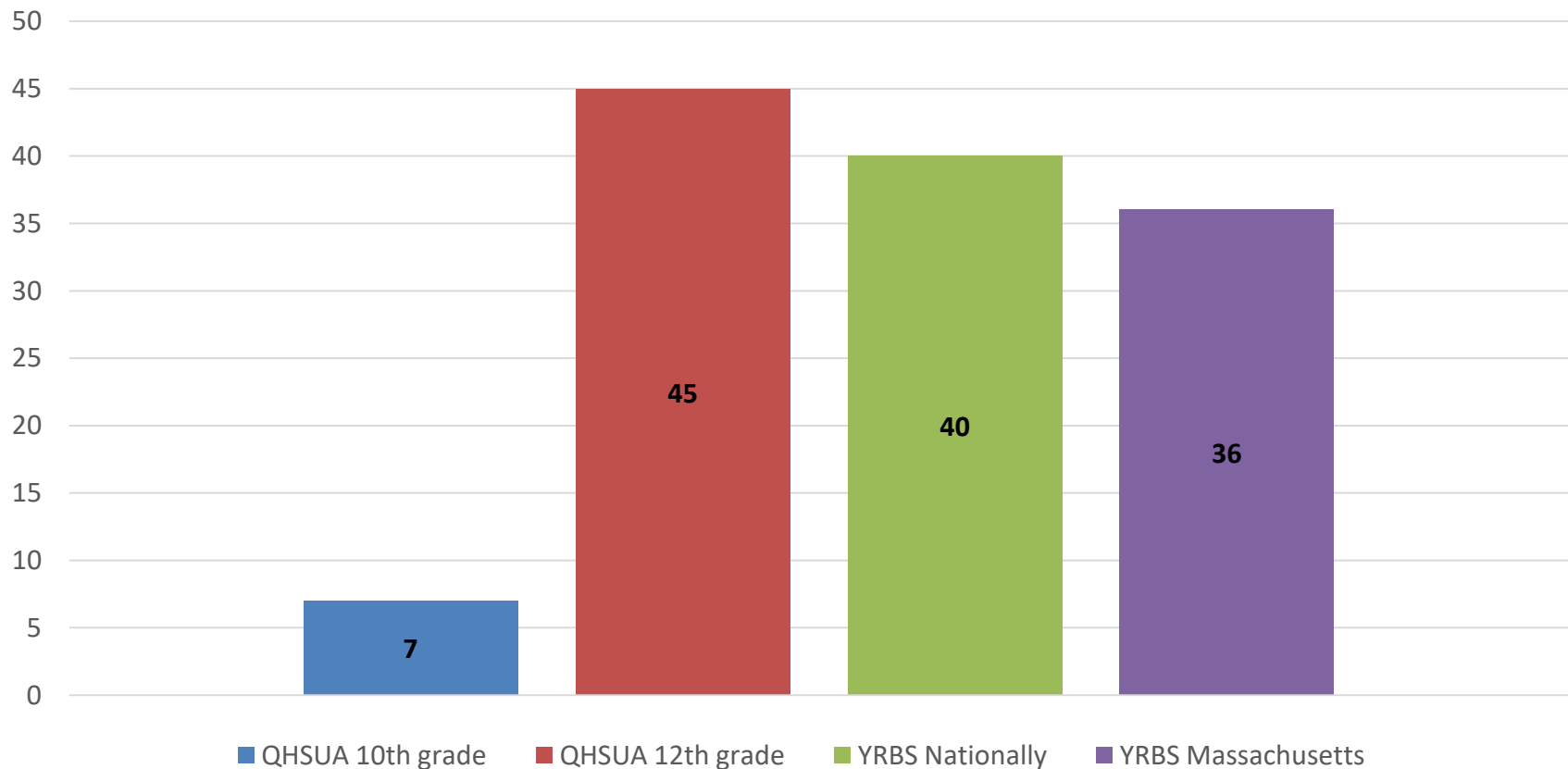
30-day frequency- based on a driver within three hours of marijuana use

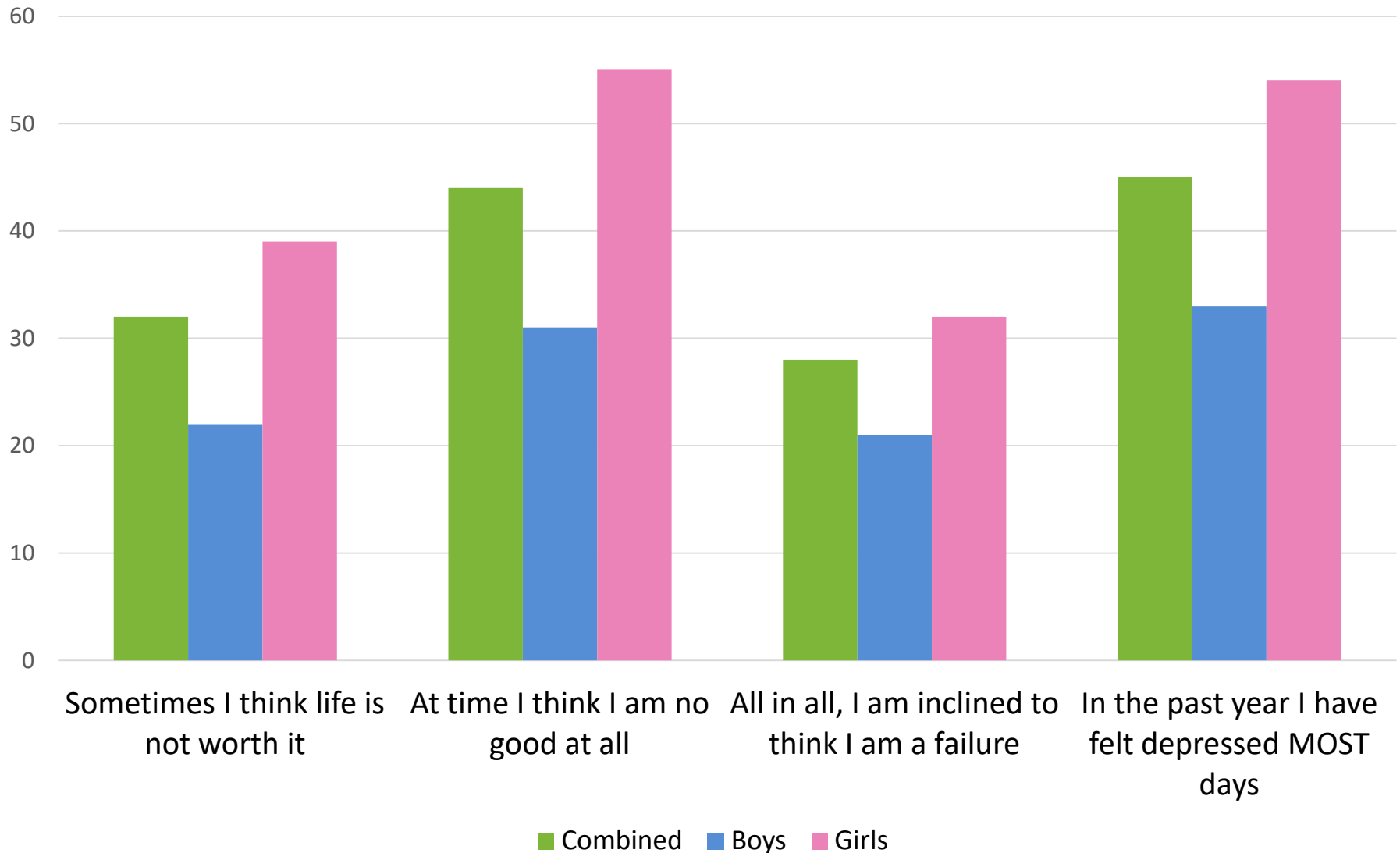
18% of female and 6% of male students report being bullied online in the past year.

Screen Time

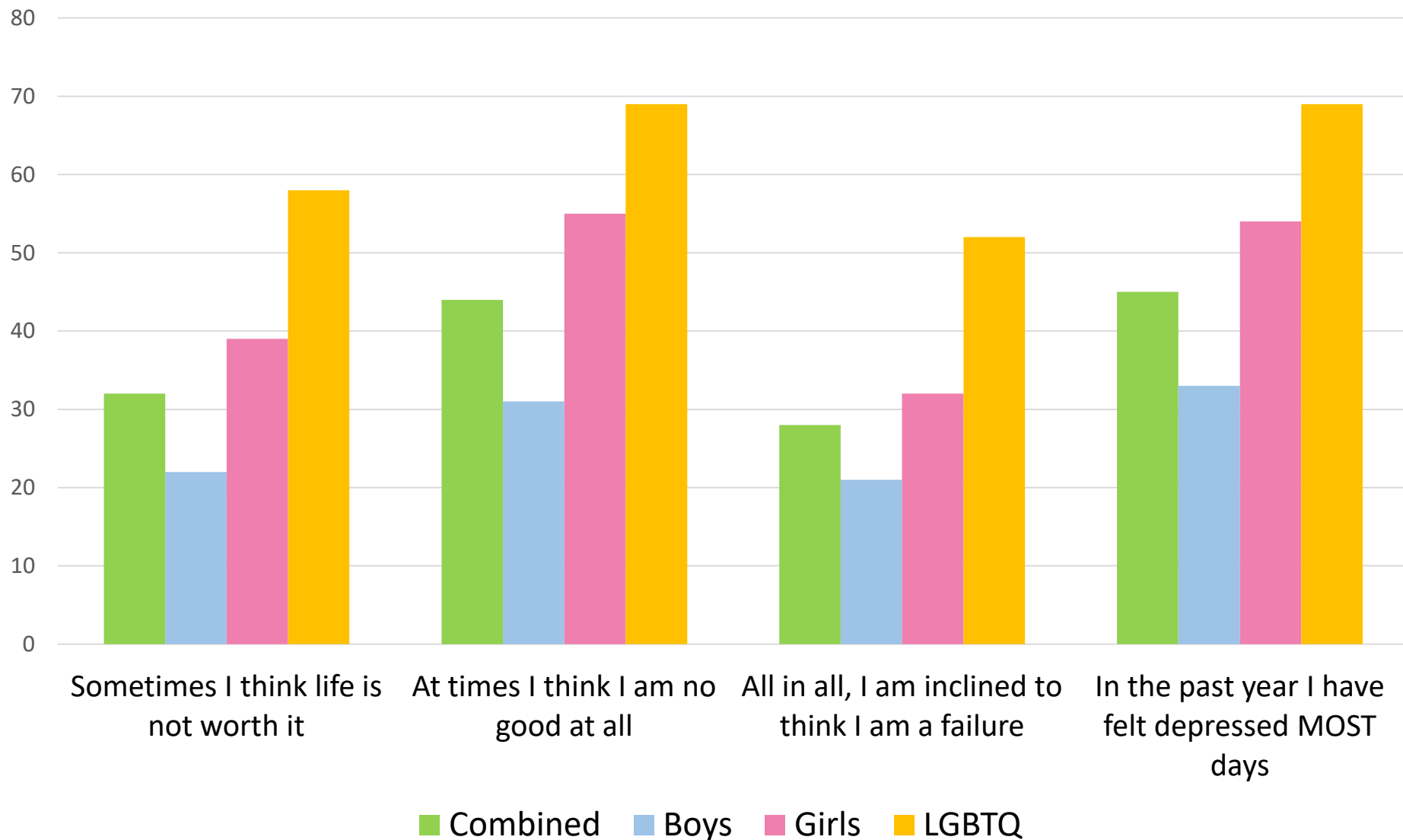
71% of all students report spending 3 or more hours of each day on TV, computers, tablet or phone.- not related to their school work.



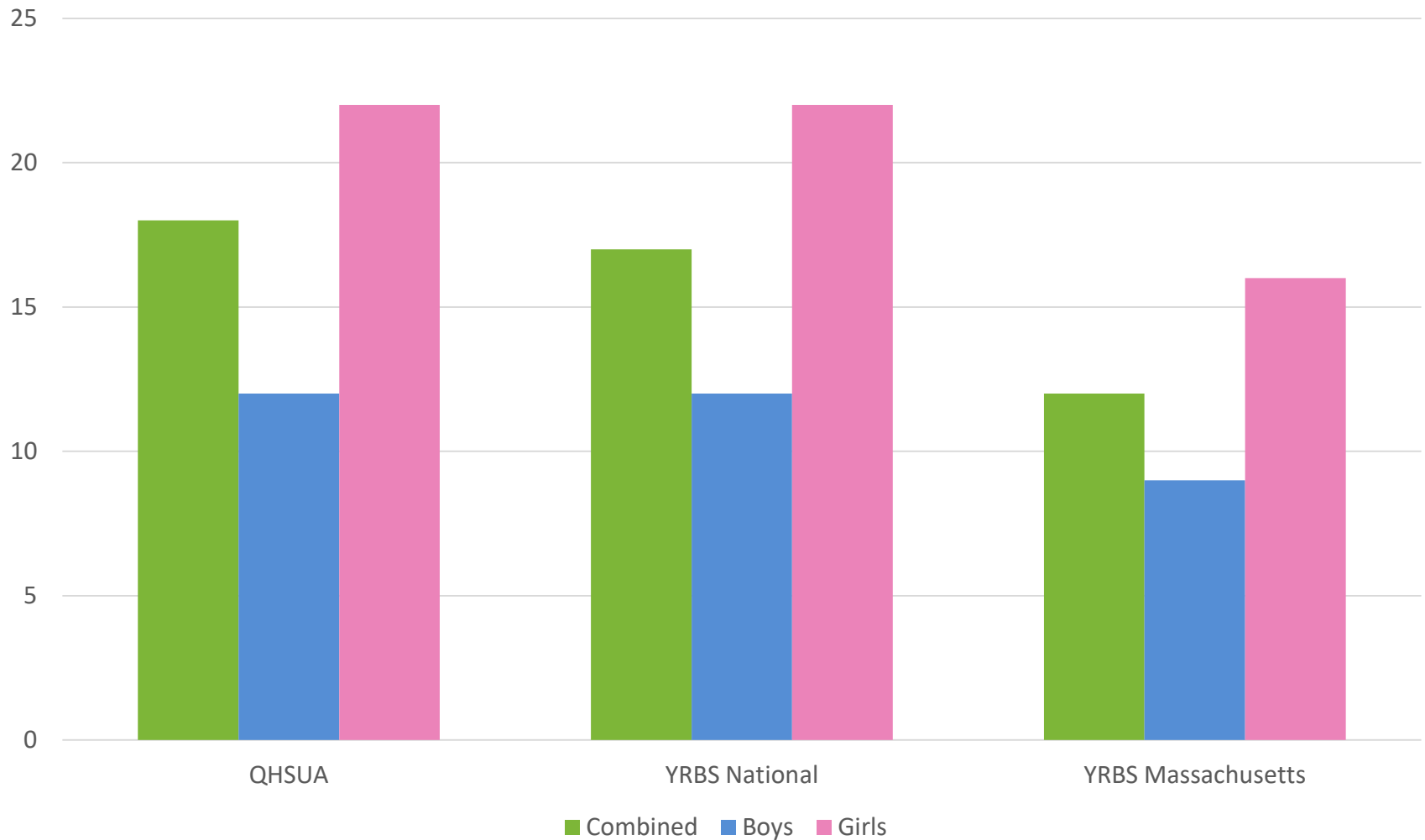
Students reporting depression symptoms



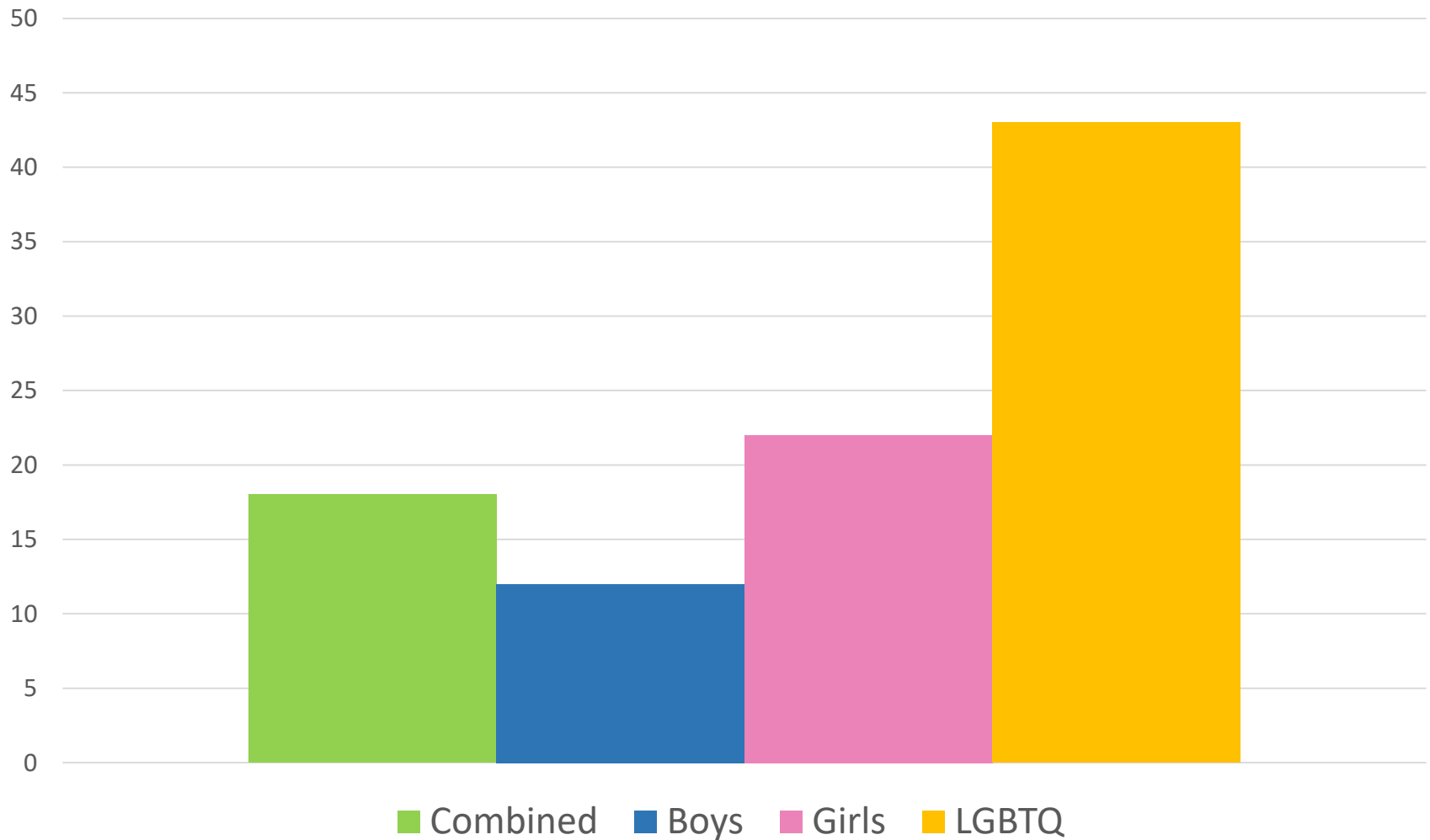

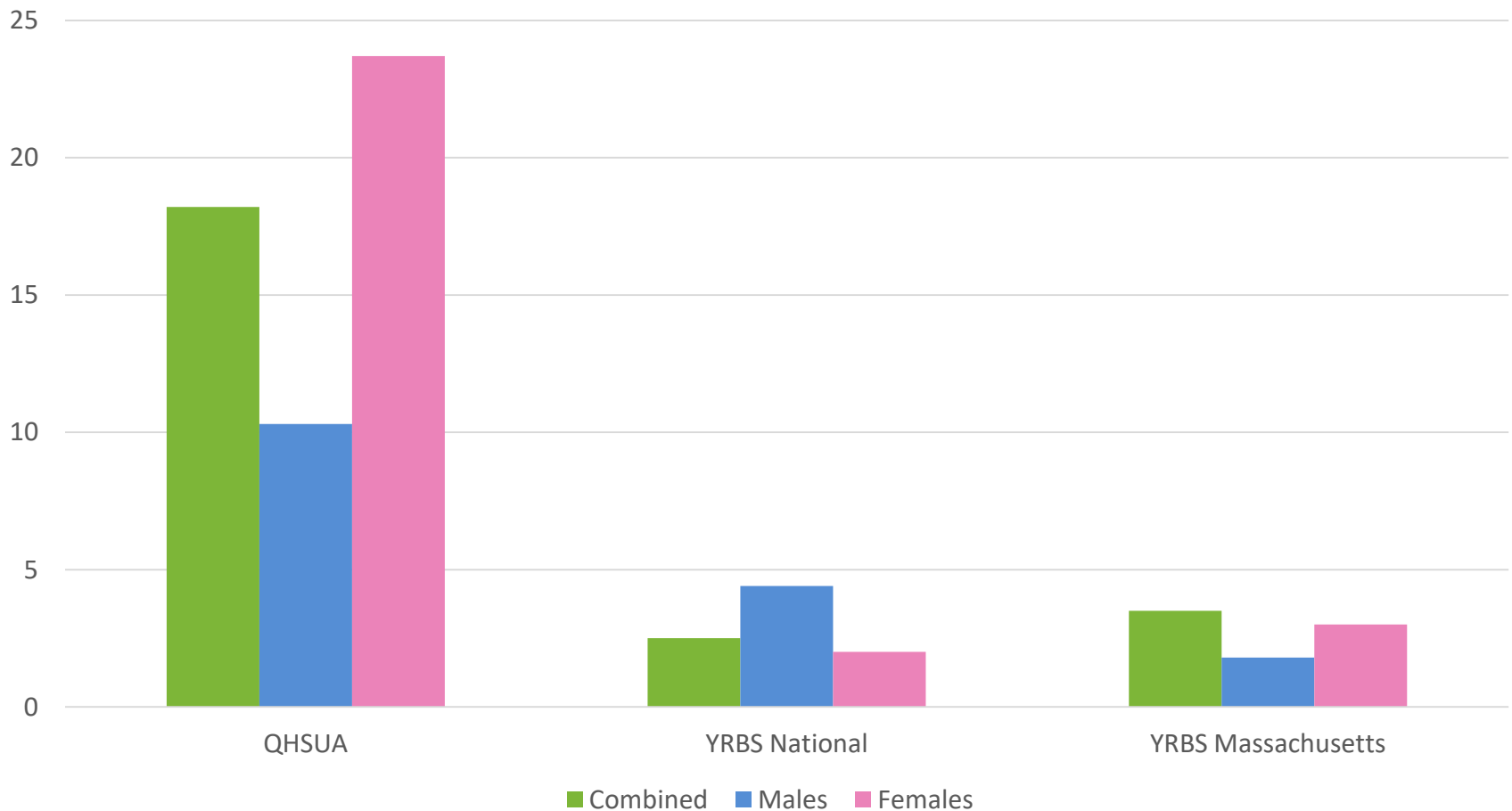
Students who report seriously contemplating suicide in the past year.



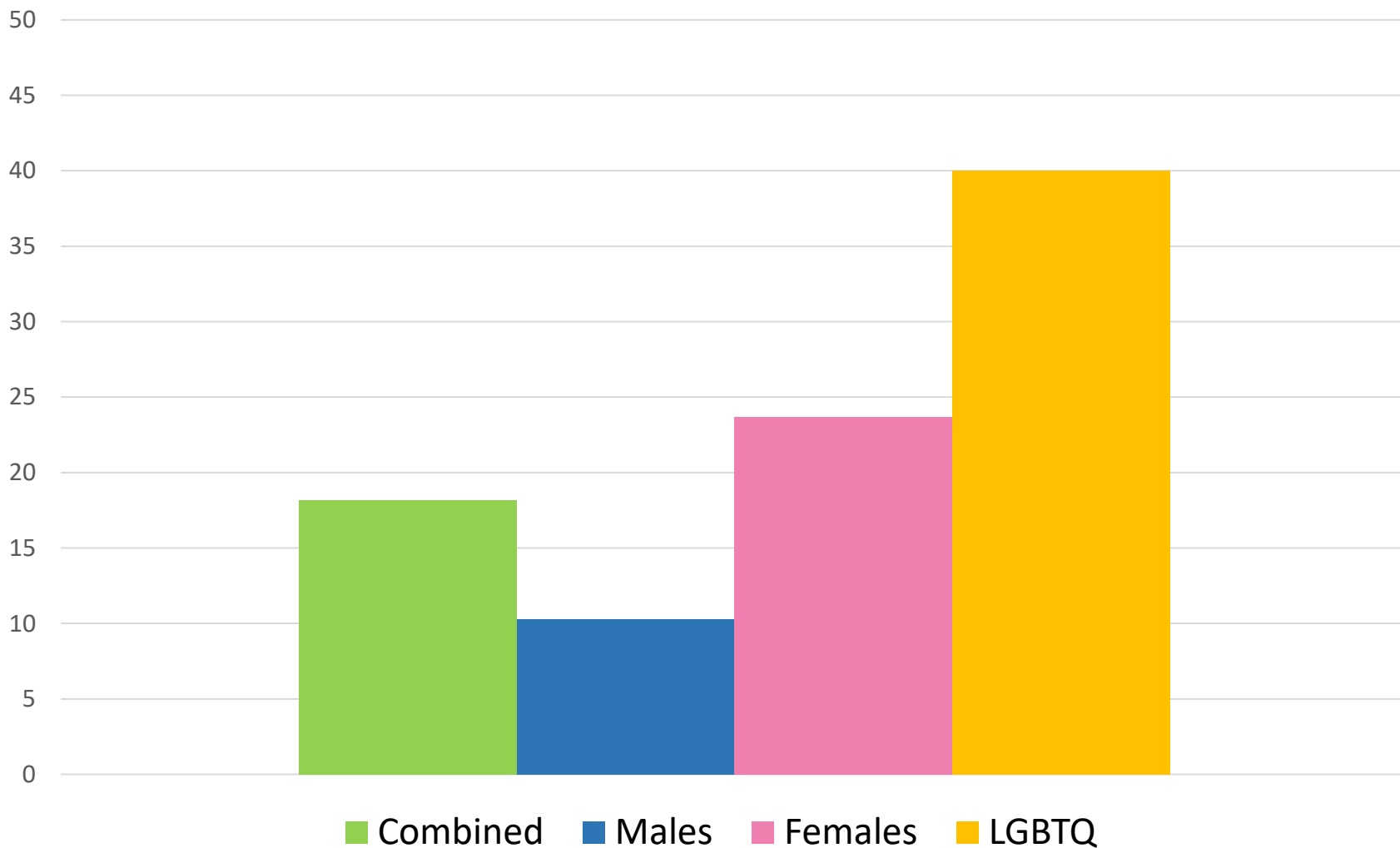

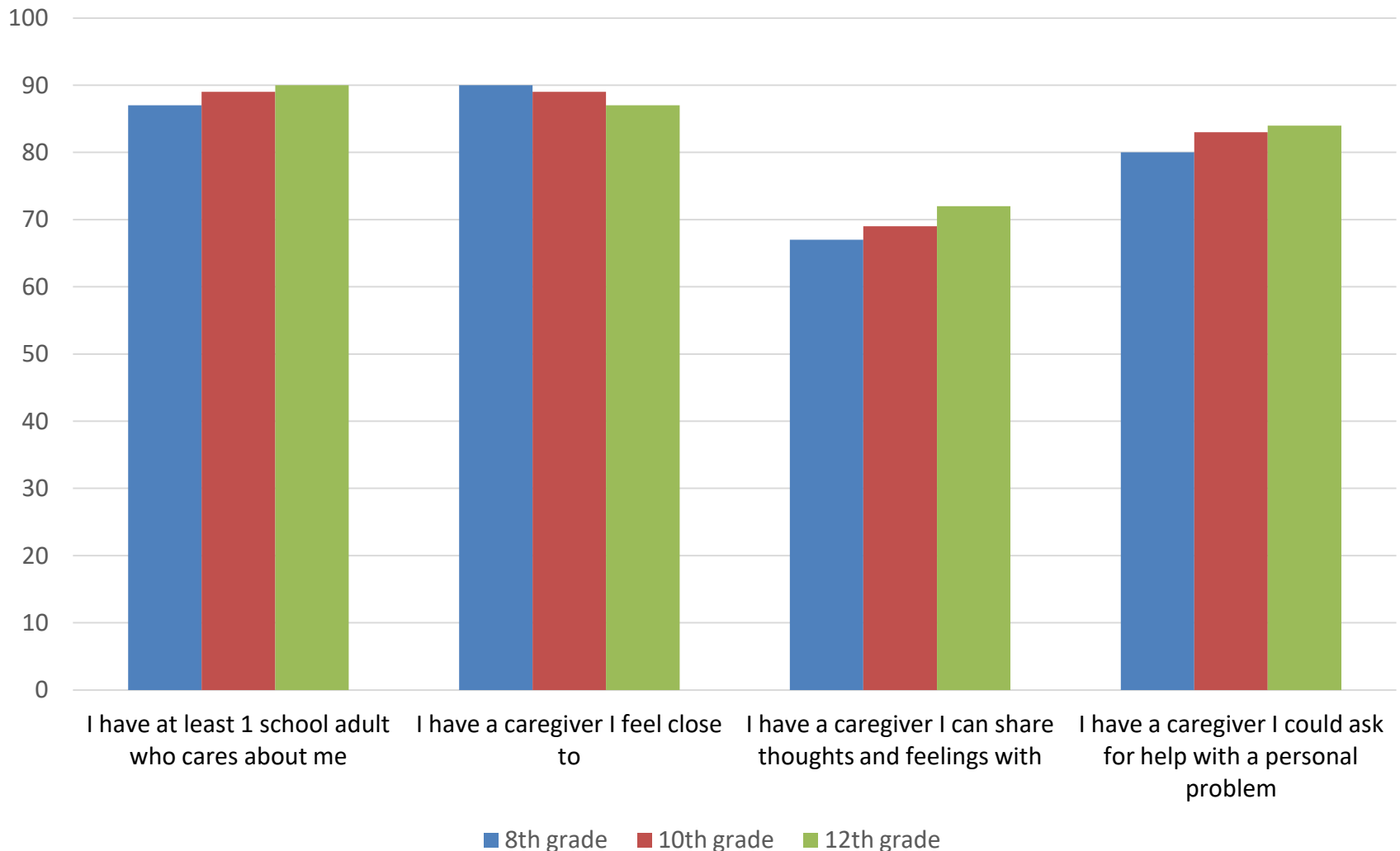
Students who report self harm, without the intent to die by suicide, in the past year

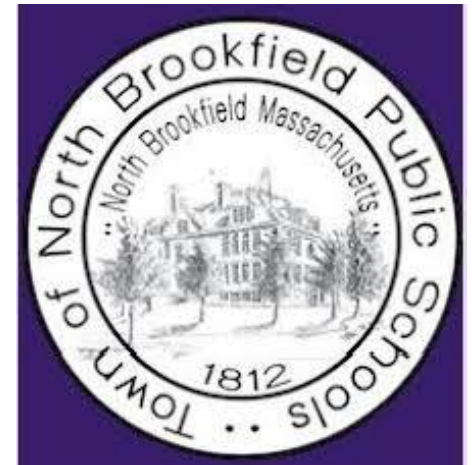

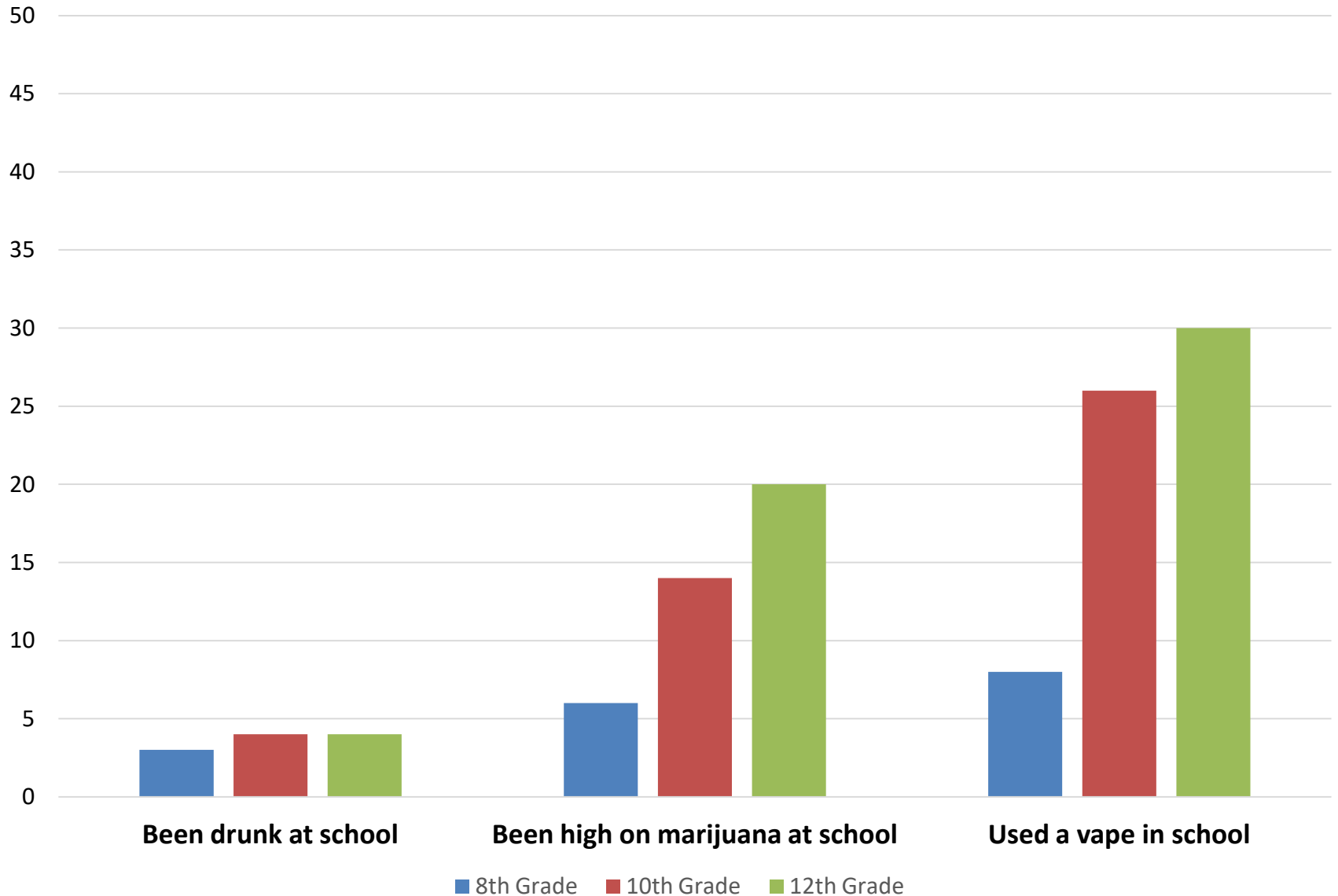

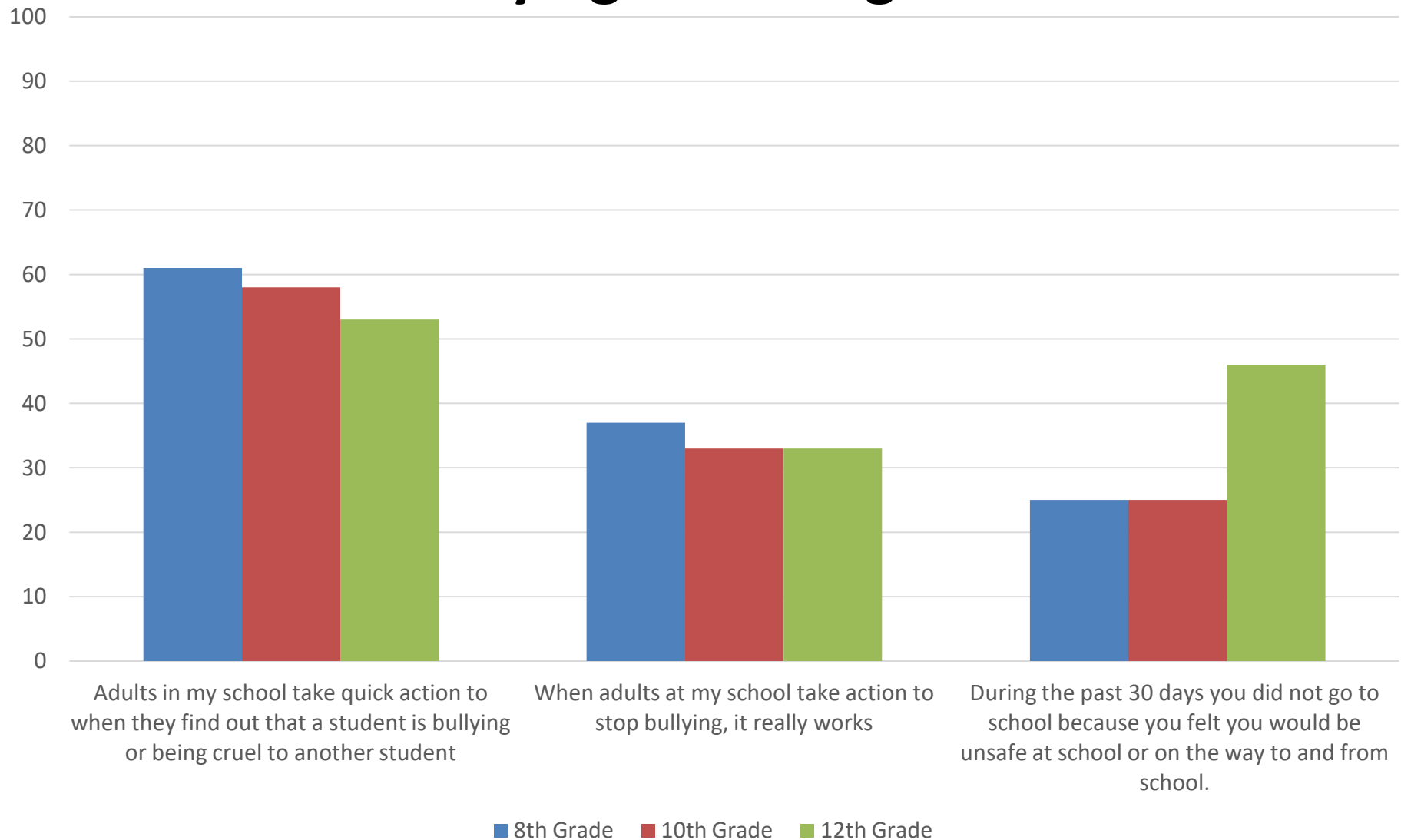

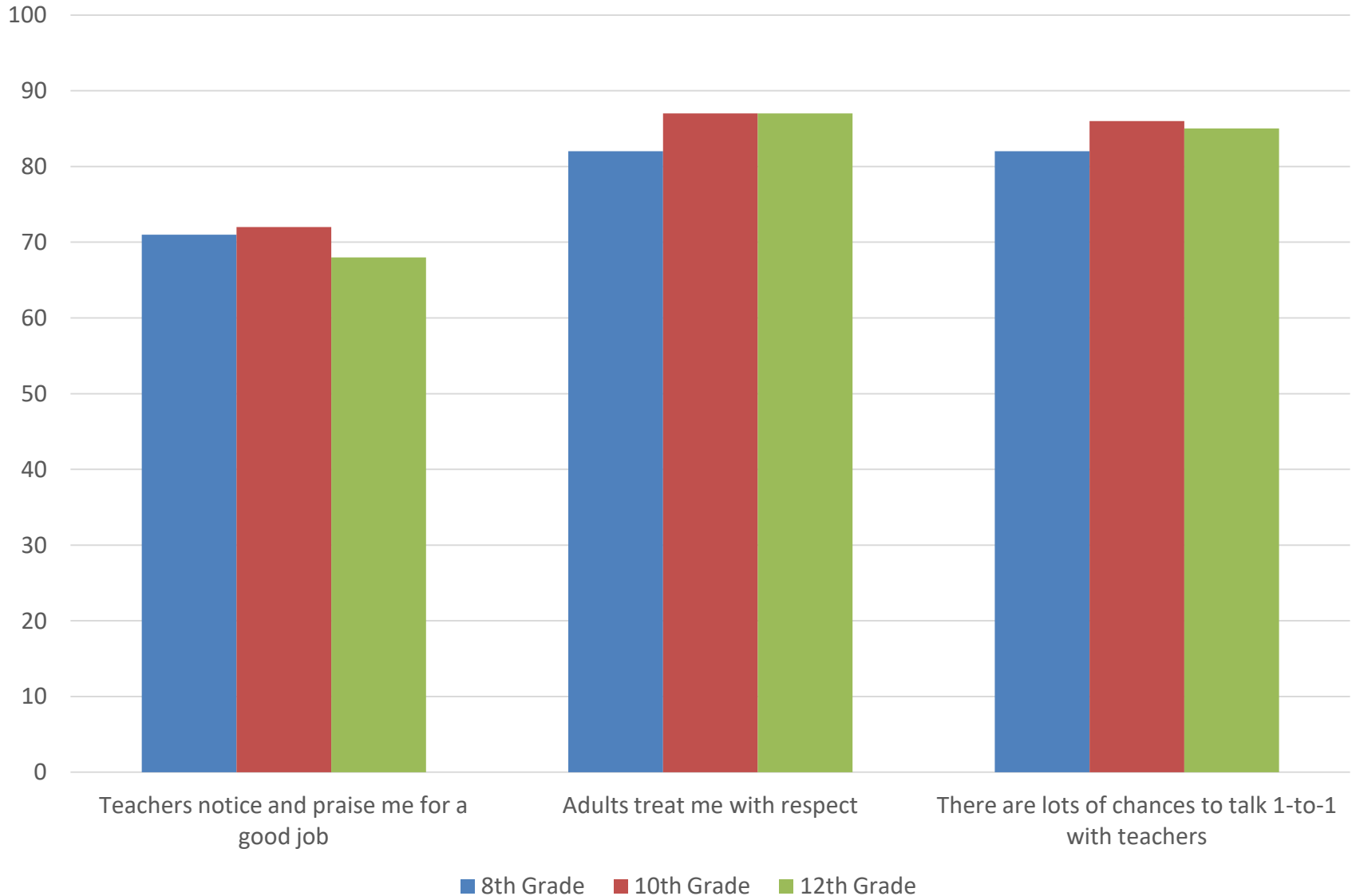

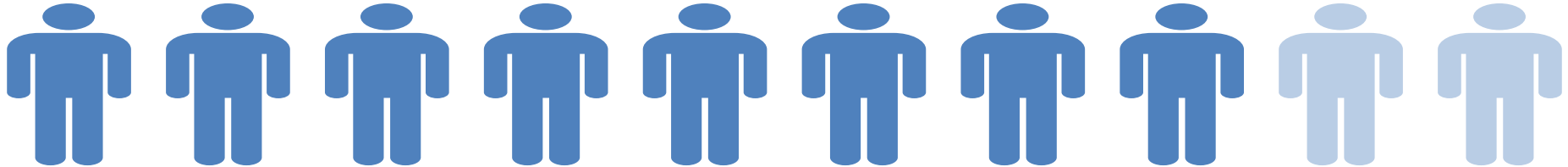
What do Quaboag Hills students say about bullying in our region?
